SECRET BALLOT ELECTION AND TOWN MEETING WARRANT *MARCH 22, 2016*

TO: Eric Blanchette, a resident of the Town of Frenchville in the Aroostook County, State of Maine.

Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Frenchville in said county and state, qualified by law to vote in town affairs, to meet at the **Frenchville Community Center** in said town on **Tuesday, the 22nd day of March, 2016 A.D., at ten o'clock in the forenoon**, then and there to act on articles numbered 1 and 2 as set out below; the **polling hours** therefore to be from **ten o'clock in the forenoon until six o'clock in the afternoon**.
