REPORT OF SELECTMEN AND TOWN MANAGER

1977 was a year to be remembered by all in the Town of Carmel. The new municipal building was completed and we moved into it the last week of November. For the first time in history, we are afforded the luxury of running water and flushes at the Town office. Of course, we are pleased with having all the extra space, and we are certain that the Fire Department and Ambulance Squad is happy to have their vehicles all under the same roof.

The lowest bid for the construction of the building was by Bowman and Littlefield of Hartland, Maine, whom we selected, at a bid price of \$161,325.00. This included the building and landscaping to eight feet outside the building. The Town had to provide the water tank, pump and piping to the well; the septic tank and chamber system used for the leach bed; the gravel for the septic system, driveway, and roadway. There will be more landscaping to do when Spring arrives. You should be proud of your new building and the fact that there is no mortgage on it.

Another big change in the Town was the closing of the open burning dump, which was effective July 1st. The roadside rubbish pickup is working very well now, after getting off to a difficult start.

As was stated in last year's town meeting, "We have been building a basketball court since I was a kid." Well, at last, it is becoming a reality. The Gravel was hauled in and leveled and the hot-top applied last fall. The backboards and nets have been purchased. As soon as we can fence around the court to protect the neighbors' property, as well as the youngsters who are playing, it will be open for fun. Hang in there, Bill.

The Planning Board has had an active year with several difficult situations to deal with. We thank each of the members for the time and concern that they have given to the betterment of the Town. Thanks also, to the Board of Appeals who had to act on two different occasions.

The State Aid Road money was used to construct and hot-top another part of Hinckley Hill Road. No Town Road construction was done, however, with the money carried forward from last year and additional funds this year, we hope to finish the Five Road and rebuild a part of the Bemis Road.

State Revenue Funds in the amount of \$12,990.12 were received and applied directly to taxes to reduce the tax rate.

A course in assessment at Bowdoin College was taken by Clement Richardson. He is now attending a course at EMVTI.

The Snowmobile Club did their usual fine job of cleaning up the roadside last Spring. Thanks to all those who helped.

The Selectmen meet each Monday evening at 7:30 P.M. at the Municipal Building. You are welcome to attend any of their meetings.



To the Citizens of Carmel:

Volunteer is our middle name and it is the thing we do the best. We volunteer our time, efforts and sometimes money to better ourselves and the service.

We had volunteers at the Baxter State fire to serve as first aiders, there were five critiques at Eastern Maine Medical Center, there were Cardio Plumonary Resuscitation (C.P.R.) classes, the Emergency Medical Technician (EMT) course, extrication classes, let alone our own drills and meetings. To volunteer all the time, spells dedication in what we are doing, for we have one goal, helping others who are in need regardless of how large or small the need may be to the best of our ability. It makes us feel that all the volunteer hours spent training was worthwhile when we succeed in helping others.

The overall level of training and education of our ambulance attendants is continually improving. We have ten members who completed the EMT course, which is longer than the published 81 hours, and have six members that are either state or nationally recognized as EMT's.

Along with the fund raising events we staged and the monies received from donations and services rendered, we were able to raise \$2,336.61; however, we spent \$2,325.33. We also have set aside funds for ambulance equipment replacement (\$2,500.00) and \$2,500.00 for education and training.

Our examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

Within the scope of our examination, the financial transactions were considered appropriately handled, with such exceptions as may be noted in the accompanying commentary.

In our opinion, the aforementioned statements for the year ended December 31, 1977, present fairly the information therein, in conformity with the provisions of Title 30, Revised Statutes, Section 5253, applied on a basis consistent with that of the preceding year.

COMMENTS

OPERATIONAL RESULTS

The current year's operations showed that a net unexpended departmental balance of \$11,644.20 was lapsed to unappropriated surplus, per the following summary:

The overlay, unallocated excise tax revenue and an unexpended balance in the contingent and costs and interest accounts less tax abatements and an overdraft in the snow removal account were the major factors contributing to the net amount lapsed to surplus. The records did not indicate that the legislative body had voted to allow overdrafts in appropriation accounts.

* * * *

The following comments pertain to the accompanying financial statements:

ASSETS . . . The general fund cash balance totaled \$51,115.38 and federal revenue sharing amounted to \$21,052.39 at December 31, 1977. The bank balances used in reconciling this amount were confirmed by the depositories. Petty cash was counted.

Taxes receivable totaled \$31,613.81 of which \$31,237.98 represented current year accounts. The remaining balance of \$375.83 was for delinquent accounts dating from 1972. Tax liens and tax acquired property amounted to \$7,527.96 and \$4,053.93 respectively.

LIABILITIES, RESERVES AND SURPLUS The departmental accounts showed an unexpended balance of \$69,678.26 carried forward to the ensuing year in accordance with customary practice and/or pending further financial activity: \$21,960.92 of the departmental balances carried is for construction of a new municipal building.

Federal revenue sharing entitlement payments for the year totaled \$19,914.00. Interest earning credited to the fund was \$439.47. Unappropriated funds totaled \$21,052.39 at December 31, 1977 and was on deposit in a savings bank. It should be noted that the townspeople authorized the expenditure of federal revenue sharing funds for new equipment, but they further stipulated that these funds could only be expended by a vote at a town meeting. No new equipment was purchased during the current year.

The unappropriated surplus amounted to \$46,111.01, an increase of \$13,695.90 for the year. This change was occasioned principally by departmental balances lapsed, interest from investments and state inventory tax refund less the excess of estimated over actual state revenue sharing funds.

TRUST AND RESERVE FUNDS Trust fund principal totaled \$13,047.71 and unexpended income was \$2,123.95 at year end. Capital reserve funds totaled \$33,741.90 at year end and represented \$724.47 for the fire department and \$10,017.43 for the general building fund.

A credit reserve fund of \$6,957.54 established for emergency tax relief was on deposit with the Bangor Savings Bank, Bangor, Maine.

GENERAL

The use of \$25,000.00 excise tax revenue and \$14,089.00 anti-recession fiscal assistance funds were voter authorized for current year operations.
