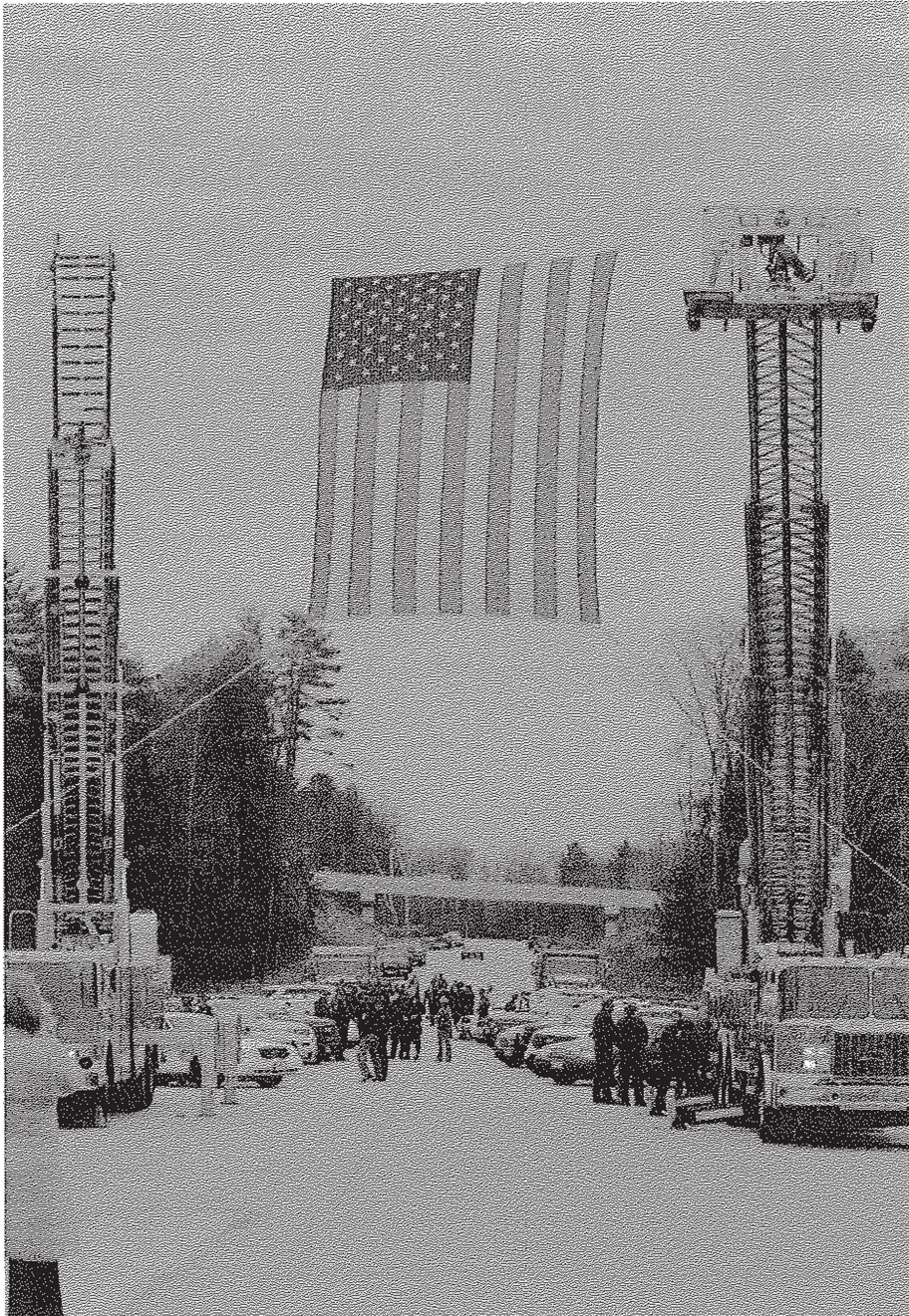

The Town of Gorham also offers an online mapping application. The WebGIS is an interactive map that runs in a web browser and provides the public with geographic data not previously accessible. Some of the data that is available includes: road centerlines, property lot lines, zoning, utilities (Sewer & Water), floodplains (Current and new Proposed FEMA Maps), and much more. Click on the Interactive GIS Maps in the "Where do I go for" section on the Town's homepage.

When are my taxes due?

Taxes are normally due November 15th and May 15th. The Town Council may occasionally change these dates if they fall on a weekend.

How can I view my property tax bills?

Access this information by going to the Town's website www.gorham-me.org. From the homepage, go to "Town Departments" and then click on "Assessing Department". Scroll down to find the link for "Real Estate and Personal Property Tax Bills". Choose the desired year to view. Choose the file with the first letter of the property owner's last name as of April 1st. If you are printing a copy of the tax bill, be sure to choose "print current page" or "print selected record" on the printer menu so you don't print the entire file.

Can I pay my taxes online?

Yes. Beginning November 10, 2014, Residents can make credit/debit card payments 24 hours a day, 7 days a week by clicking on the Online Transactions Link found in the "Where Do I Go For" section on the Town's home webpage. Property taxes can be paid with a Visa, MasterCard, Discovery, or American Express card. Payments are processed through Maine PayPort Online, a third party service working in partnership with the Town of Gorham. By using this third party service, your credit card information is processed through a secure site. For any questions regarding this service, please call (207)222-1611.

Maine PayPort will assess a 2.5% service fee for each transaction; however, all transactions that are \$40 or less will only be charged a \$1.00 fee. **PLEASE NOTE:** Overdue taxes may **NOT** be paid using this service and must be paid at the Town Office.

To pay your bill, you will need the account number located on your tax bill and a valid credit card. If you are unsure of your account number, or the amount owed, you can call the Town Clerk's Office at (207)222-1670.

How can I view my property assessment information?

You can access this information by going to the Town's website www.gorham-me.org. From the homepage go to "Town Departments" and then click on "Assessing Department". Scroll down to "Current Property Tax Data (Vision)". Click on the link to view information on property, including assessed value and photo of building(s).

Do I have to apply for the Homestead Exemption or Veterans Exemption every year?

No. Once approved, your Homestead Exemption is in place and will carry over from year to year. If you move, you will have to submit an application for the new property.

Where can I get a burn permit?

Weather permitting; residents are able to obtain burning permits during the hours of 8:30am to 4:30pm, Monday through Friday and on Saturday and Sunday from 8:30am to 12:00pm at NO CHARGE. Burn permits are also available at no charge (only during the above listed hours) from the Town of Gorham website at www.burningpermit.com.

At other times you are able to obtain burning permits from <http://www.maineburnpermit.com> at a fee of \$7.00, 24 hours a day, 7 days a week.

How can I get a Fireworks permit?

You can apply for a fireworks permit by going to www.fireworkspermit.com or go to the links on the Town of Gorham's Web Page or Gorham Fire Departments Web Page. Residents, who are 21 years old and are going to use the fireworks on their own property or have written permission to use some else's property, may apply for a Fire Works permit Monday thru 12:00 PM Saturday. If weather allows and the Town is issuing burning permits, those that have applied will have their fireworks permit approved after 09:30 on Saturday morning. No permits will be available after 12:00 noon on Saturdays. Once the permit has been approved, you must print it, sign it and have it with you while using the fireworks. You must be at least 150 feet from any structure.

What do I need to get my car registered?

For **FIRST** time registrations, the person or persons to whom the vehicle is being registered must come in to process the registration. Anyone can re-register a vehicle.

Do you accept credit cards?

The Town of Gorham offers the convenience of accepting credit cards or debit cards for payments. Due to the fees charged to the Town by the Bank to process these transactions, a non-refundable convenience fee will be applied to cardholders who wish to pay via credit card or debit card. The fee will be disclosed at the time of the payment transaction with the option for the cardholder to decline the fee and make the payment via check or cash. A fee of 2.45% of the transaction amount will be charged for any amount over \$122. A \$3.00 minimum will be charged for any transaction amount under \$122.

How can I obtain a passport?

As of May 1, 2011 and until further notice, the Town Clerk's Office will no longer be accepting passport applications due to changes in the Western Hemisphere Travel Initiative. Passport photos may still be obtained in the Town Clerk's Office. Applications may be processed at the Gorham Post Office.

When will my trash be picked up? What if there is a holiday?

There are several different trash pickup days, depending on where you live. You can look up your area by logging onto the Town website and going to the "Trash and Recycling Information" link from the Public Works Department page. You will also find alternate schedule information as well as other useful information on recycling.

Who do I contact if I come across a stray dog or cat?

You can reach the Animal Control Officer by calling Dispatch at 839-5581.

REPORT OF THE TOWN MANAGER FOR FY 2013-14

It is my pleasure to provide the Annual Report for the fiscal year beginning July 1, 2013 through June 30, 2014, to the Town Council and the citizens of Gorham.

During the last fiscal year, the Town made good progress on a number of projects and issues important to the Town. As the year progressed, the local economy continued to get stronger with renewed interest from developers to subdivide property. The Town issued 80 permits for single family homes and condominiums compared to 79 permits issued the prior year. Back in the 2008-09 fiscal year, the low point of the recession, the Town only issued 27 permits. The Town also issued 43 Commercial permits compared to 44 a year ago.

The new Great Falls Elementary School opened in the fall of 2012, and the White Rock School closed. Initially, the Town Council appropriated \$175,000 to demolish the White Rock School Building. However, after going through a process of soliciting proposals to redevelop the old school, the Town sold the former White Rock School property to Great Falls Construction in July 2013. Great Falls Construction plans to build 12 one bedroom apartments to serve the elderly segment of our population. This project has the added benefit of placing this property back on the property tax rolls.

The Little Falls Recreation Area was developed in the 1970s with the assistance of a Federal Grant and has been heavily used by the Community. It was never laid out in an efficient configuration that made the best use of space. In August 2013, the Town Council approved a new Master Plan to guide the future development of the Little Falls Recreation Area that over time should make more efficient use of the property. The plan calls for the eventual removal of a large hill on the site to make room for more fields and also redesigns some of the area allowing for more fields to be developed. Several months later, the Council voted to appropriate recreation impact fee funds to begin the process of implementing the new Master Plan. The first step is to develop engineering plans for a multi-purpose athletic playing field. The Council also approved a Master Plan for the playing fields located behind Village School. The eventual development of these sites will provide additional athletic fields as the community continues to grow in the future.

In September 2013, the Town Council approved a new Municipal Development and Tax Increment Financing District (TIF District) for Martin's Point Health Care. Martin's Point Health Care has been in Gorham for a while, and needed more space than they had at their rented property on lower Main Street. Since the Council approved the TIF District, this project has been through the approval process with the Planning Board and construction started in the spring of 2014. This new health care facility will cost about \$5 million and is located at the corner of Mosher Road (Rt. 237) and Main Street (Rt. 25) and will provide an

attractive building as visitors come into Gorham and continue along Main Street towards the Village. The new facility is expected to open in September 2014.

In October, the Town Council amended the Hansen Contract Zone located at the intersection of County Road (Rt. 22) and South Street (Rt. 114), to facilitate the development of a new Cumberland Farms Store. This project has now been through the site plan approval process with the Planning Board and construction has started on the project. The new store is expected to be open in the fall of 2014.

Also in October, the Town Council voted to appropriate Recreation Impact Fee funds to amend the Town's current Site Location and Development permit for the Chick Property. This is an amendment that must be obtained through the Maine Department of Environmental Protection and will lay the foundation for multiple projects for additional recreation facilities on the Chick Property located behind the current Public Safety Building on lower Main Street. These recreation projects will then be constructed over time as new Recreation Impact Fees become available.

In December, the Town Council voted to accept a proposal to update the Town's Village Master Plan approved by the Town Council on March 14, 2000. The plan guided development in the Village and has served the Town well. The village looks very different than it did in 2000. However, much has happened in Gorham since 2000 that affects the Village, including the construction of the Bernard P. Rines Highway (the Gorham Bypass) that opened in December 5, 2008 and reduced vehicle traffic through the village. The consultant has just begun to work on the update as the fiscal year comes to a close.

Earlier in 2014, the Town Council began a process of updating the Town's Comprehensive Plan adopted in May 1993. The Council held public hearings in January and February to review citizen comments and also held a workshop in March. Gorham's population has grown by about 38% since 1993. Strong residential development increases the price of land and thereby increases the pressure on the farming segment of the community to convert their farm land to residential development. The Council asked for assistance from the Maine Farmland Trust to help develop strategies that could be considered for inclusion in the updated Comprehensive Plan to strengthen farming and agricultural businesses in Gorham. As this report was being drafted, the Comprehensive Plan was still a work-in-progress with a lot left to be done in the next fiscal year.

As the end of fiscal year 2014 was coming to a close, the voters of Gorham rejected a \$6.3 million dollar project that would have constructed a new Public Safety facility on Acorn Street at the location of the former Little Falls School. Comments from citizens indicated that the project was too expensive and that they preferred to have the Police and Fire Departments closer to Gorham Village. In April the Town Council indicated that they had heard the voters and hired Port City Architecture to perform feasibility and cost study to develop the Public Safety facility at 270 Main Street. They also asked the architect to develop plans for a project that would cost \$5 million or less. Working with our Public Safety staff, the Architect quickly went to work and was closing in on a plan that would meet the goals set by the Town Council while also providing the modern public safety facility that Police and Fire need to effectively do their work. I am anticipating a project that will be presented to the Town Council in July or August with the project then going to the voters in November 2014.

With the Public Safety Project location shifted away from the Little Falls School area, the Town moved forward on improvements to the former Little Falls School and entered into a contract with Great Falls Construction. This project will replace the old inefficient heating system with natural gas. Other improvements will be made to the roof and windows. The building will then be used for recreation programs and provide space for community meetings.

At the request of the Trustees of Eastern Cemetery and a subsequent request from the Trustees of the Saplin Hill Cemetery, the Town Council began a process to take over the assets and operations of the two cemeteries. This was a lengthy process requiring the State Attorney General and Probate Court to approve the transaction. The process was completed in January 2014, and the Town Council voted to accept the assets and administer the cemeteries.

Other action taken by the Town Council during the 2013-14 fiscal year included accepting three new public roads: Town Common Road, Snowberry Drive and an extension of Harding Bridge Road that added approximately 1.14 miles to Gorham's existing road network. The Council also approved an updated Capital Improvements Plan and appointed a Historic Preservation Committee to review the Town's historic buildings and make a recommendation to the Town Council about whether to develop an Ordinance to help preserve these assets. The Town Council also ordered a plaque to commemorate the Town's 250th anniversary of the Town of Gorham's incorporation, which is on October 30, 2014.

Several other important changes occurred in this past year. First, the University of Southern Maine (USM), which has a residential campus in Gorham, continued to struggle with reduced financial support from the State and with declining enrollment from students that started during the recent recession. These enrollment reductions have caused USM to reduce employment and make reductions in some of their program offerings.

On a more positive note, several years ago Shaw Brothers Construction developed a new headquarters building on Mosher Road. This past year, Shaw Brothers followed up that investment by extending additional natural gas capacity to the facility and installing a paving plant. Both of those are significant new investments in the Gorham Community and provide the prospect of new employment and continued growth for the company.

I am very pleased to report that the Town of Gorham has again received a Certificate of Achievement for Excellence in Financial Reporting from the Government Finance Officers Association. Gorham has received this recognition for 10 consecutive years and is one of the few communities in Maine to receive this distinguished award.

I would like to take this opportunity to express my appreciation to all of the citizens who take time out of their busy lives to serve on our Boards or Committees. I also want to express my appreciation to all of the folks who volunteer to help in our many Recreation Programs or at Baxter Memorial Library or serve in some other capacity. You help us provide many valuable services that make our community special. Most important, your energy helps us stay focused on what is important and exemplifies the spirit of Gorham. Thank you for all you do for our community.

Finally, I would like to express my appreciation to all of our full-time, part-time and temporary employees who provide professional, high quality services every day. Your dedication to help the Town meet and respond to the challenges is greatly appreciated. Thank you for your daily commitment to the Town and its citizens.

ASSESSING DEPARTMENT

The Assessing Department assigns and updates tax values on all existing and new tax parcels in Gorham using a computer based assessing program (Vision), including a geographic information system (GIS) component. This process includes property inspections and technical data entry, sales studies and analysis, and changes within the system when appropriate. We provide a wide range of property information to real estate professionals and others through the Town of Gorham web site and over the telephone, through email, and in person at our office. We review and assign addresses and tax map/lot numbers for newly created lots and subdivisions and frequently work with contractors, other Town of Gorham departments, and Emergency-911 agents regarding address issues, including the E-911 mandated naming of driveways. We also process all property owner transfers and maintain files on each taxable parcel. We digitally store deeds and maintain sale price records. Annually we produce updated tax maps of all real estate tax parcels in Gorham.

We also administer a number of tax exemption programs and special use designations including tree growth, farm use, open space, homestead, veteran, and blind exemptions, and the personal property BETR and BETE programs that result in tax savings for Gorham property owners and businesses. We provide assistance and question resolution regarding these exemptions and tax reduction programs. Annually, we compile a total value for all assessed taxable property and respond to a variety of State of Maine reporting requirements.

CODE ENFORCEMENT OFFICE

The following services are provided by the Code Enforcement Office: review applications and issue permits (building, electrical, plumbing, septic system, sign and use permits), conduct inspections pertaining to the aforementioned, assist the public with zoning matters, assessing information, (copies, deeds, etc.), investigate complaints and enforce ordinances, codes and certain state laws, and provide staff support for the Zoning Board of Appeals. The CEO sits on the Site Plan Review Committee and confers with the Planning Department. The CEO and Assistant CEO reviews building plans and proposals going to the Planning Board and Site Plan Review Committee in addition to compliance regarding Planning projects on-going and completed, along with working closely with the Fire Department to ensure compliance with related codes, administer the Small Community Grant Program for the replacement of malfunctioning septic systems for qualified applicants, and work in conjunction with the State Electrical Inspectors Office, State Planning Office and the DEP to ensure compliance with relevant state and local laws and ordinances. The CEO interprets ordinances and codes and makes determinations on ambiguous or questionable parts thereof (subject to appeal).

Gorham Access staff maintains the broadcast and technical functions for two PEG (Public/Educational/Government) TV stations. Management of streaming video system and other on-line video content is also handled by staff. Production studio and office is located at the Gorham Municipal Center.

Channel 3 – the government and education station is staffed by GOCAT and records and programs for broadcast of municipal and school meetings as well as information provided by county and state departments. We provide official information pertinent to citizens regarding their government.

School and Town events are well documented through the efforts of the staff in recording and editing. GOCAT is present 24 hours a day on the Time Warner Broadcast System and over the internet. Our on-line activities continue to grow as technology expands. Realizing that the future of communications will be centralized to the World Wide Web, we are finding we need to devote more hours to this area.

Other duties that support the Town & School Departments include: requests for informational productions, media support, audio/video support, designing presentations, video edits, and media duplication. The Station Manager maintains technical operations and repairs for the TV Studio and broadcast functions for both channels.

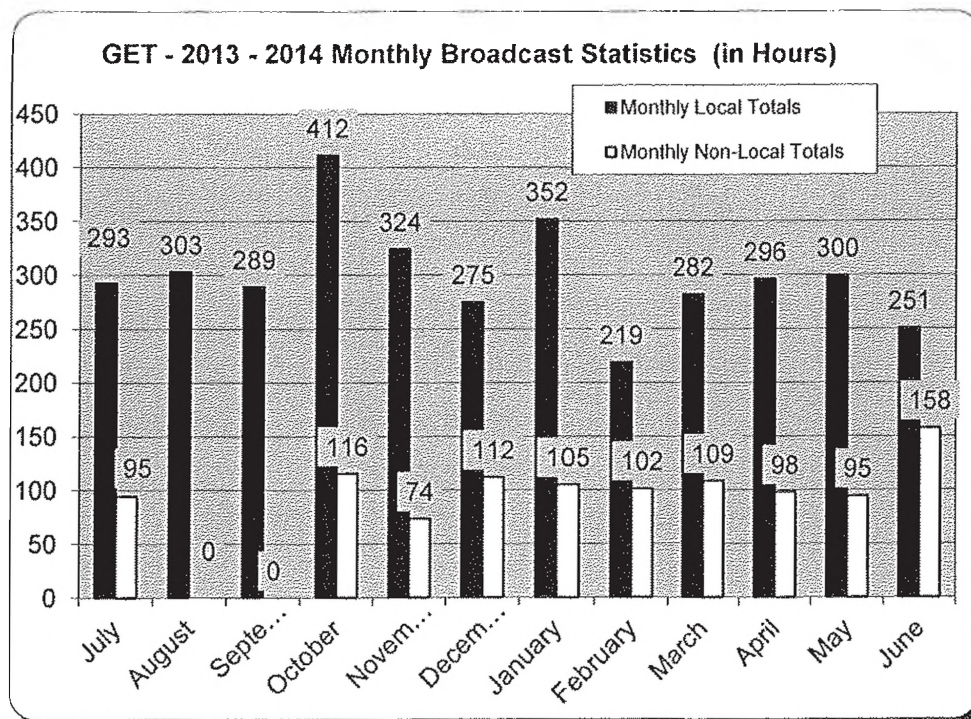
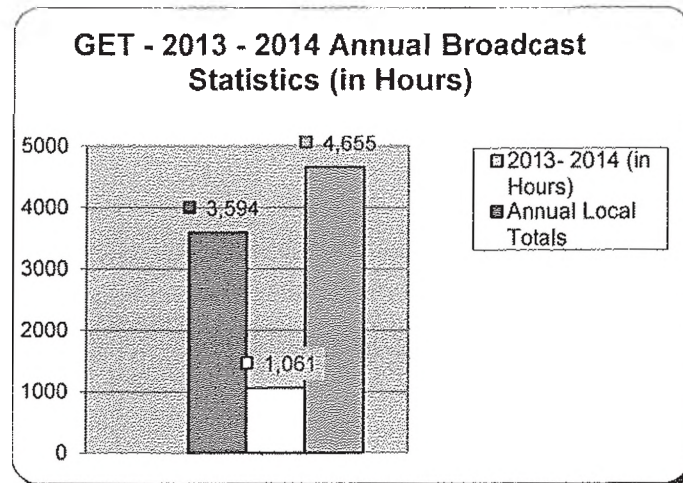

Re-Broadcast of governmental programming.

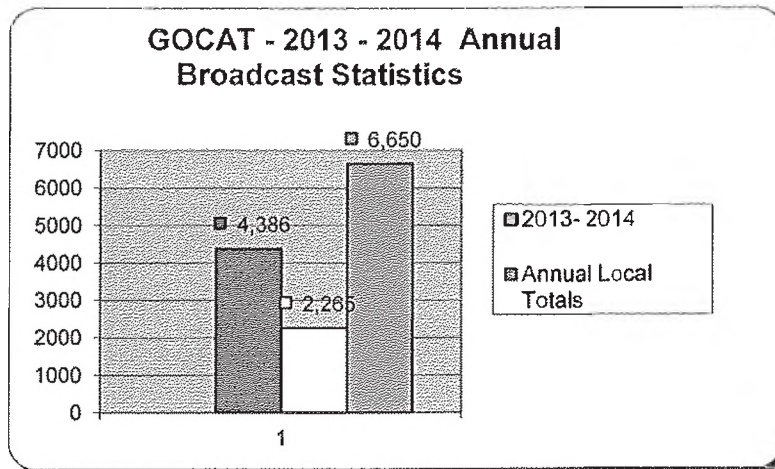

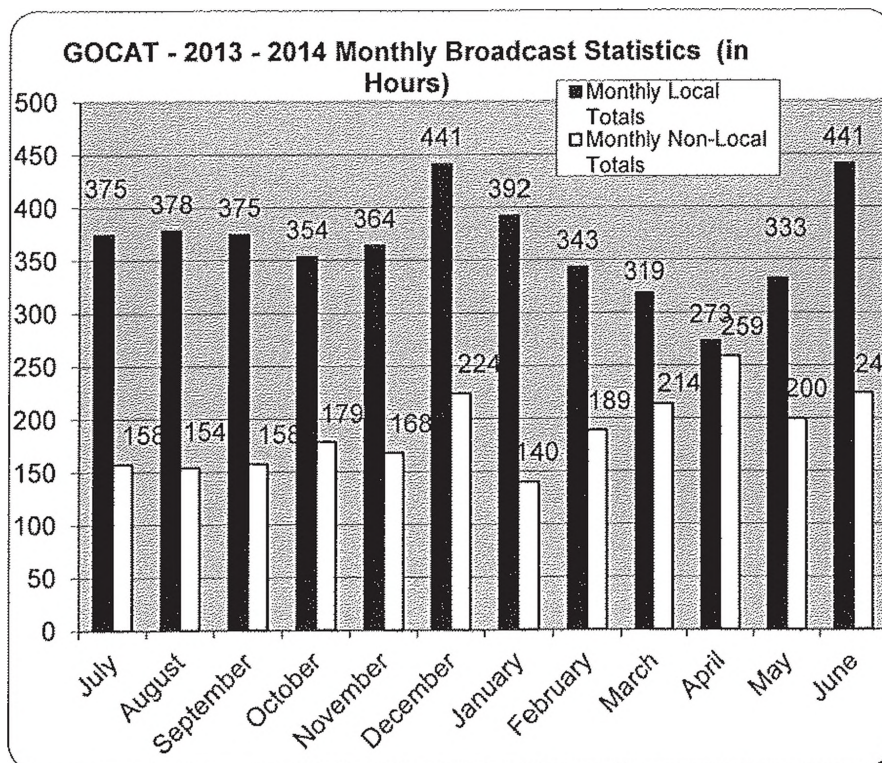

Updates: The change of services from Time Warner Cable as of June 5, 2013 seems to have gone well with few complaints. GOCAT shifted to digital format and the majority of Gorham customers apparently purchase upper tier services and the digital change went unnoticed.

HD (high definition) is now the industry standard. GOCAT is doing some conversion such as the purchase of digital cameras. The system installed in the chambers and studio needs to be upgraded if possible. Staff has had problems with some of the functions in the Council Chambers, especially with the podium and presentations.

GORHAM ECONOMIC DEVELOPMENT CORPORATION

The Gorham Economic Development Corporation (GEDC) has prepared this activity report as a way of providing an account of its development efforts and results for the prior year. The Corporation's focus is to engage in business attraction and retention practices that will allow for the expansion of the business community in Gorham, thereby stabilizing and expanding the tax base and creating jobs for its citizens. While constituted as a stand-alone corporation, it is funded by the Town of Gorham. Staff also participates in special development projects including managing the town's revolving loan fund, grant applications, and regional planning efforts. The Corporation is staffed by 1 part-time employee and is overseen by a 9 member volunteer Board of Directors which meets monthly.

2013/2014 has been another good year for the Town in its business attraction and retention efforts.

Attraction

Gorham had another solid year in terms of attracting companies to town. The Hopyard, Robert Precision Electric, The Blue Pig Restaurant, Eastern Communications, Classic Poker Chips, Southern Maine Specialties, and The Maine Real Estate Network, are notable examples of businesses that made Gorham their new address in the past year.

Retention/Expansion

ODAT Machine, Shaw Brothers Construction, East Coast Communications, White Rock Outboard, Easy Aquariums, Plowshares Community Farm, Gorham Chiropractic, and Cumberland Farms all expanded their operations in Gorham in the past year.

Special Projects:

An \$80,000 grant was approved through Cumberland County Community Development Block Grant Program for Sidewalk improvement in Little Falls and is in process.

The new Gorhammaine.org web site and "Grow with Us" branding campaign completed in 2013.

PLANNING DEPARTMENT

The Planning Department provides planning assistance and technical support to the Planning Board, the Administrative Review Committee, the Town Council and the general public. The staff coordinates the review of all proposed land use development applications requiring approval by the Planning Board or the Administrative Review Committee. The Department also oversees special planning projects, the development and adoption of new ordinances and amendments to the Land Use and Development Code, as well as the Official Zoning Map of the Town.

During the current fiscal year, the Planning Department has processed applications for 39 new developments and amendments to previously approved projects, and 14 applications carried forward from 2013, for a total of 53: 32 have been approved, 2 were withdrawn, and 19 were carried forward for completion in FY 2015. The Planning Board and staff also prepared and/or reviewed 9 zoning amendments and 3 Contract Zone applications, with 5 zoning amendments and 3 Contract Zone applications being adopted by the Town Council and 4 zoning amendments being carried forward for completion in FY 2015.

PUBLIC WORKS DEPARTMENT

The Public Works Department is primarily responsible for the maintenance of over 146 miles of Town roads and 14.98 miles of State roads. This road maintenance work includes, but is not limited to, the maintenance of pavement (summer and winter), markings and striping, signage, bridges, culverts, ditches, traffic lights, trees, picking up dead animals and trash in the roadway, mowing of grass within the roadway, cleaning of catch basins, and street sweeping. In addition to roadway maintenance, Public Works also conducts capital road improvement projects, building, cemetery and facility maintenance, cemetery burials, mowing and trimming of Town grounds, and oversees the curbside collection "Pay-Per-Bag" and recycling program. Public Works, through the Public Works Director, assists with development plan review and construction and coordinates the Town's GIS Program. Public Works also assists every other Town Department and the School System in a variety of capacities when needed.

**PUBLIC WORKS DEPARTMENT
TRANSFER STATION
SOLID WASTE AND RECYCLING**

The Public Works Department maintains the two existing closed landfills, including the administration of the required water testing program.

The transfer station is open for grass clippings and leaf drop-off during normal business hours and is open by appointment noon to 1 p.m. Monday through Thursday for the disposal of motor oil. The transfer station is also open during two Saturdays in the spring and two Saturdays in the fall for brush disposal.

The Pay-Per-Bag curbside program began in July 1, 2002 and includes the collection of solid waste and recyclable materials. In 2014 EcoMaine eliminated the annual assessments to Towns. DPW estimates that approximately 2,400 tons of solid waste is handled by the curbside collection contractor annually. 176,250 15-gallon trash bags and 96,000 33-gallon trash bags were sold in FY14.

RECREATION DEPARTMENT

Gorham Recreation Department provides people of all ages opportunities for activities and experiences that support healthy living and community involvement. The Department offers wide a variety of youth and adult sports programs, family outdoor recreation opportunities including hiking, biking, skiing, canoeing and a host of community special events including concerts, festivals, holiday celebrations and camp activities for grades K-8 on a year round basis.

The Town Clerk's Department coordinates and oversees all state and local Elections, voter registration and petition verification; sells cemetery plots and schedules burials for many cemeteries in town. This office also provides the following services; recreational and motor vehicle registrations, fishing and hunting licenses, property and excise tax collection, dog licenses, marriage licenses and marriage ceremonies, certified copies of birth, death, and marriage records, genealogy research, passport photos, notary services, Dedimus Justice services, town trash bag, recycle bin and curbside disposal tag sales. The following licenses and permits are processed through the Town Clerk's Department; massage therapist/establishment, victualer's (food establishment), junkyard/automobile graveyard, liquor, special amusement, coin-operated amusement device, large outdoor events, waste/refuse haulers, mobile home park/campgrounds, sole proprietor & partnership certificates, and door to door solicitation.
