## 2017 MAPLETON TOWN MEETING MINUTES

At 3:00 pm Susan Skidgell opened the Meeting by reading the following statement.

#### GREETINGS:

As directed, Sue Bragdon, Clerk of the Town of MAPLETON, in the county of Aroostook and the State of Maine, have had Dennis Hoffses warn and notify the inhabitants of MAPLETON who are qualified by law to vote in the Town affairs to assemble 3:00 pm Monday, March 20, 2017 at the Mapleton Lions Hall for purpose of acting on Articles 1 & 2

True attested copies of the warrant were posted at the Mapleton – Castle Hill – Chapman Town Office, Mapleton One Stop and the Post Office. All being public and conspicuous places for the Town of MAPLETON

Art. 1 To elect by majority on written ballot, a moderator to preside at said meeting.

At 3:00 pm Nadiene Brewer nominated Penny Kennedy as Moderator with Bonnie Steeves seconding the motion. No further nominations were made. Skidgell asked for at least three written ballots to be cast. 3 ballots were cast. After the voting ceased, the ballots were counted. All the ballots were for Penney Kennedy. Kennedy opened the polls and read Article 2.

Art. 2 To elect by majority on secret ballot, according to the provisions of the Revised Statutes of Maine, Title 30-A, Section 2528: One (1) Select Board Member for a term of three (3) years; One (1) Assessor for a term of three (3) years; and One (1) Sewer District Trustee for a term of three (3) years.

At 7:00 pm Kennedy swore in Wesley Lavigne as Deputy Moderator. Lavigne read the following articles and asked for action from the audience of approximately 20 residents.

Art. 3 To see if the Town will authorize the municipal officers to choose all necessary municipal officials for the ensuing year.

Art. 5 To see if the Town will vote to charge interest on taxes unpaid as of a certain date; if so, how much and what date.

Art. 13 To see what sum the Town will vote to raise and appropriate for General Assistance. Any overdraft to come from the Undesignated Fund Balance.

Art. 15 To see if the Town will vote to approve the following total anticipated revenues from State Revenue Sharing, Local Road Assistance Program, Surplus Use and all other revenues, as estimated, and appropriate said sum for the purpose of reducing the overall Tax Commitment:

Said appropriations comprised, as follows:

Art. 17 To see if the Town will vote to increase the property tax levy limit of \$445,717 established for the Town by State law in the event that the municipal budget approved under the preceding articles results in a tax commitment that is greater than the property tax levy limit.

If the preceding articles are not changed, then vote to take no action on this article. Otherwise, SELECTMEN RECOMMEND: Approval

Motion to take no action on Article 17as we are under the tax levy limit: Robert Bagley

Art. 18 To see if the Town will vote to authorize the municipal officers to appropriate all interest earned or capital gains realized on Reserve Accounts as Interest Earned Revenue.

Question: How are donations handled?

Answer: Donations are handled on a case by case basis. All donations go through the Select

Board Members.

Art. 26 To see if the Town will vote to authorize the municipal officers, on behalf of the Town, to sell and dispose of any real estate, however acquired, on such terms as they deem advisable, to execute a municipal quit claim deed without covenants on such property, and to lease property and sell stumpage on such terms as they deem advisable. Real estate sales shall be offered by sealed bid after notice of sale has been advertised for two (2) consecutive weeks, unless the property is offered to the previous owner for accumulated taxes, interest, and other costs against said property.

Comment: Selling stumpage, should the select board members consider water rights, mining rights – comment noted.

Art. 27 To see if the Town will vote to authorize the municipal officers, on behalf of the Town, to apply for, accept and expend grant funds from state government agencies, federal government agencies, or private organizations, for any purpose they deem in the best interest of the Town.

Question: Do we have nay grants pending that we have applied for?

Interim Town Manager, Theresa Denbow answered, "No".

Art. 28 To see if the Town will vote to authorize the municipal officers, on behalf of the Town, to accept gifts and real estate which may be given to the Town, and to accept funds from the State of

Maine, the United States and from other identified sources, and to appropriate any funds received to specified or appropriate accounts or funds.

#### **SELECTMEN RECOMMEND: Approval**

Motion to accept the Selectmen's Recommendation on Article 28 as written: Robert Bagley Second: David Maxcy

Motion passed by a show of cards

Art. 29 To see if the Town will vote to authorize the municipal officers to execute contracts of terms three (3) years or less, for services deemed in the best interest of the Town.

#### **SELECTMEN RECOMMEND: Approval**

Motion to accept the Selectmen's Recommendation on Article 29 as written: Robert Bagley Second: David Maxcy

Clarification: What contracts are we talking about?

Interim Town Manager, Theresa Denbow and select board members answered, Phone service, mowing, the municipal building was painted, most contracts are annually, some are three years. Motion passed by a show of cards

Art. 30 To see if the Town, in accordance with the Revised Statutes of Maine, Title 36, Section 506, will authorize the tax collector and town treasurer to accept prepayment of taxes not yet committed and to pay no interest thereon.

#### **SELECTMEN RECOMMEND: Approval**

Motion to accept the Selectmen's Recommendation on Article 30 as written: Robert Bagley Second: David Maxcy

Question: Why don't we pay interest on prepayment of taxes?

Interim Town Manager and Select Board Members answered – it is the customer's choice to pay early.

Motion passed by a show of cards

Lavigne announced the results of the election and are as follows:

Selectman (3 year term) David Dunlavey with 24 votes

Assessor (3 year term) David Maxcy with 25 votes

Sewer District Trustee (3 year term) Jeffrey Cray with 26 votes

No further business was discussed. A motion to adjourn was made by Robert Bagley and seconded by David Maxcy. The meeting adjourned at 7:27 PM.
