To the Citizens of Island Falls:

The school work has been carried along during the year with little change from the regular routine with few exceptions, among which is a plan to change the system of grading so that the scholars who are able to do the required work can enter high school at the end of the eighth grade and save a year of school life. This means that the scholars will be required to do the whole work as arranged under our present system in eight years, not including the sub-primary. One reason for making this change is that the greater number of schools having as long school year as we have and graded similar to ours is working on the eight year plan. Another is, we have a sub-primary for the first year and first grade for the second and children who have attended school regularly will be ten years in reaching high school except in a few cases where we have arranged half year promotions. We feel that the time has come when we can make the change with beneficial results. The present eighth grade will undoubtedly be prepared for high school by the close of the school year with the possible exception of a very few and those who are not able to complete the work and who remain another year will enter high school as soon as they would if we should continue our present system. We have about forty in the seventh grade and the indications are that about thirty will be able to complete the work at the end of the eighth grade while the remaining ones will require the extra year. This seems to be fair to those who can go shead and save a year of school life, without any injury to those who are unable to do so.

We have varied the work in the domestic science department somewhat from last year. We have been able to do much more as it is being taught on full time this year. But little has been done with the high school students and we shall do little or nothing next as it was our original plan to have it apply to the high-school for two years and confine it to the grades thereafter. We have carried it down to the fourth grade and have included in it more than a hundred girls. The room is well arranged and

equipped and we note with satisfaction the broadening of the work and its value to so large a class of girls.

The fall term opened with three new teachers in the grades and one in the high school. At the end of the fall term we were very sorry to lose Miss Noyes but were able to fill her place with a sub-master. The work in all the schools is going more smoothly and with more apparent satisfaction than at any time for the past few years. We have an exceptionally strong teaching force whose work ought to be and we believe is appreciated.

The new building and the Barker Ridge house are in excellent condition and will need but slight repairs. A new furnace, a coat of paint, new seats and inside repairs will be needed for the old building. More grading should be done on the village school grounds.

It has been the plan of the school officials to make the schools as efficient as possible without adding new departments or increasing the burden of taxation. We have worked with that end in view and the efficiency of the schools and condition of the finances indicate that we have succeeded.

We have met with one irreparable loss in the administration on our schools in the resignation of Mr. Milliken from the school board, but as he has been called to the highest position in the gift of the voters of the state, the Governorship of Maine, we gladly accept it for the good of the whole state, and use it as a living example for every boy in our schools who has the determination to get the most out of life by putting the most into it.

We wish to thank the citizens for their kind support in so many ways and trust that our school conditions meet their approval.

Warrant for Annual Meeting

To J. H. Lurvey. Esq., one of the Constables of the Town of Island Falls, . Greeting:

In the name of the State of Maine, you are hereby notified to warn the inhabitants of said town of Island Falls qualified by law to vote in town affairs, to assemble at Pettingill's Hall in said Island Falls on Monday, the twenty-sixth day of March, A. D. 1917, at ten o'clock in the forenoon to act upon the following articles, to wit:—

First. To choose a Moderator to preside at said meeting.

Second. To choose a Town Clerk for the ensuing year.

Third. To choose three Selectmen, and all other necessary town officers.

Fourth. To see what sum of money the town will vote to raise for the repairs of roads and bridges.

Fifth. To see what sum of money the town will vote to raise for the support of the poor.

Sixth. To see what sum of money the town will vote to raise for town expenses.

Seventh. To see what sum of money the town will vote to raise for town debt.

Eighth. To see what sum of money the town will vote to raise for the payment of interest.

Ninth. To see what sum of money the town will vote to raise

for abatement and discounts.

Tenth. To see what sum of money the town will vote to raise for common schools.

Eleventh. To see what sum of money the town will vote to raise for repairs of school houses.

Twelfth. To see what sum of money the town will vote to raise for insurance, apparatus and supplies.

Thirteenth. To see what sum of money the town will vote to raise for text-books.

Fourteenth. To see what sum of money the town will vote to raise for free high school.

Fifteenth. To see what sum of money the town will vote to raise for cemetery.

Sixteenth. To see what sum of money the town will vote to raise for hydrant rental.

Seventeenth. To see what sum of money the town will vote to raise for street lighting.

Eighteenth. To see what sum of money the town will vote to raise for fire department.

Nineteenth. To see if the town will vote to allow a discount, and if so, at what rate, and the time to which said discount shall run.

Twentieth. To see if the town will vote to fix a time when taxes shall be due and payable.

Twenty-First. To see if the town will require the collector of taxes to settle in full with the town, and fix the date therefor, and to fix his compensation. Also to see if the town will vote to charge interest on taxes, and from what date.

Twenty-Second. To see if the town will vote to authorize the Selectmen to hire the sum of two thousand dollars, as a temporary loan, to be paid from the current year's taxes.

Twenty-Third. To see if the town will vote yes or no, on the question of appropriating and raising money necessary to entitle the town to state aid as provided in section 20 of chapter 130 of the public laws of 1913.

Twenty-Fourth. To see if the town will vote to raise and ap-

propriate in addition to the amount regularly raised and appropriated for the care of ways and bridges and highways, the sum of \$533.00 which the town is allowed to raise under the provisions of section 19, chapter 130, of the public laws of 1913.

Twenty-Fifth. To see if the town will vote to raise money, and what sum, for the maintenance of state and state aid highways, during the ensuing year, within the limits of the town, under the provisions of sections 9 and 18, chapter 130, of the public laws of 1913.

Twenty-Sixth. To see if the town will vote to raise a sum of money, and how much, to make a piece of permanent road, on the so-called Walker road in this town.

Twenty-Seventh. To see what sum of money the town will vote to raise for the painting of school houses.

Twenty-eighth. To see what sum of money the town will vote to raise for Memorial Day, and appoint a committee to expend the same.

Twenty-Ninth. To see if the town will vote to raise a sum of money equal to five cents per capita of the inhabitants, to be expended by the Board of Health toward the suppression and prevention of tuberculosis.

Thirtieth. To see if the town will vote to continue the course in domestic science for the coming year, and appropriate and expend a sum of money for said purpose, of which one-third shall be raised by taxation.

The Selectmen hereby give notice that they will be in session at said Pettingill's Hall on the day of said meeting, to correct the list of voters.
