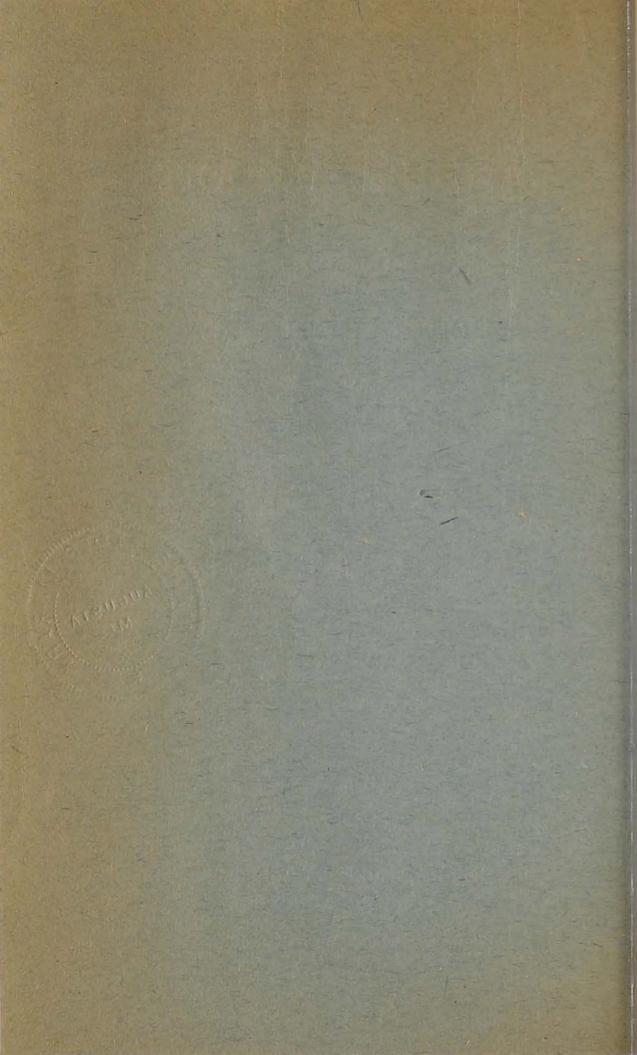

AUDITOR'S REPORT

Year Ending February 28, 1948

REPORT OF FIRE DEPARTMENT

During the past year the Fire Department answered a total of 52 calls, 38 chimney fires, 1 grass fire, and 8 fires in the town of Island Falls with an estimated damage of \$30,550.00; one chimney fire and three fires in the town of Crystal with an estimated damage of \$45,500.00 and one call to Sherman Mills.

We are now well equipped with the exception of $2\frac{1}{2}$ in. hose. We have a total of 2000 feet, 550 feet which is new hose that was purchased the past year, and 800 feet is in very poor condition and will not stand very much use.

The new truck purchased the past year is a big addition to the town's equipment. The booster tank is a wonderful help in putting out chimney fires. We have used the booster line to put out two small fires with a very small amount of water. We have had very good support from the citizens of town in our undertaking. The Firemen's Ball and Carnival were a big success.

We purchased a coat for each fireman, six helmets, two pair of boots and are in hopes to add more to these for the comfort of the firemen. We also purchased for the Department from our own fund two 15 pound CO2 fire extinguishers, one salvage cover, small tools, rope, chain, two Indian pumps, nozzle extension for chimney fires, \$29.00 for Fire School, \$14.00 Dues for Aroostook Fire Chief's Association.

An alarm system has been installed with a bell in each fireman's home at a cost of \$32.00 and an operating cost of \$8.50 per month for the system. When reporting fire, call the operator, give name of building, street, and whether it is a chimney fire or not.

The Fire Department would greatly appreciate the cooperation of all drivers of automobiles and trucks, when going to a fire, that they would be careful not to leave them parked in such a manner as to hinder the work of the firemen.

When school opened following the potato picking vacation Mr. Stuart Haskell of Houlton had been added to our Faculty. Mr. Haskell teaches mathematics and English. He is very cooperative and has done a fine job. He is very well liked by the students and faculty.

Miss Corrigan has worked into our group as a very helpful teacher. She is working with the Glee Club and assisting Mrs. Harding with the One-Act Play. She is very conscientous and cooperative.

Mrs. Quinlan has carried on her fine work with the commercial students. Outside of the class work she has been class advisor to the Senior class, helping them with many projects to earn money for their class trip and Graduation, as well as directing the Senior play and production of the Log.

Mrs. Harding handles our Social Sciences and directs our Student Council. She has been very successful this year in accumulating a sum of money for the new gymnasium. Through her efforts the Juniors and Seniors enjoyed a very educational trip to Augusta to visit Legisla-

ture. Through her efforts the students have worked under the supervision of Mr. Mack and repaired and painted the walls in four rooms.

We feel very proud of our library that Mrs. Harding has worked on for several years. She has been able to secure a large number of books and magazines for the students use. We wish to express our appreciation to the many organizations and individuals that have made contributions of books, magazines, or money.

Besides doing all of her regular work, Mrs. Harding has taken on the one new phase of extra-curricula work that we put in this year, debating. With the fine help of Supt. Bagley they turned out a very successful Debating Team.

During the fall term a group of parents and friends met and worked out a plan to secure Mr. Emmons Robinson of Houlton to organize a band in our school. They authorized Mr. Robinson to purchase what base instruments that normally are owned by the school and the Student Council have loaned over \$200.00 to the committee to pay for these instruments.

We expect to have a band concert in the near future and look for the support of all.

Mrs. Banton and Miss Dwyer in the eighth and seventh grades are doing good work in preparing the students for high school. Miss Dwyer has coached our girls Basketball team this year and has done well with them.

Our boys in Basketball have done much better than in the past few years. They were second in the Katahdin Valley League and have participated in the Aroostook County and the State Small Schools Tournaments.

Our Mid-Winter Carnival was held on March 4th, this year with several neighboring schools attending.

Our Basketball boys and girls put on one benefit game for the new Gymnasium this year and sponsored a four school Tournament to help make sure of having a good place to play in the future.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Superintending School Committee and Citizens of the Town of Island Falls:

It is a pleasure to submit this, my fifth annual report concerning the condition of your school system.

School conditions in general have not changed much in the last year. Supplies are easier to obtain, but the prices are about the same. Teachers are as much in demand as ever In fact, elementary tachers will probably be harder to obtain this year than before. There will be a few more available for high schools, altho these will be strictly inexperienced.

We have been fortunate in retaining all but three of our present teachers from last year. Miss Dawn Dwyer, a graduate of Ricker Jr. College, has taken the position held last year by Mrs. Dow. Miss Hellen Corrigan and Mr. Stuart Haskell are new to the High School faculty. All are doing good work and are helping with extra curricular activities. Miss Dwyer coached girls basketball and Miss Corrigan is helping with plays. In the Houlton St. school all of the teachers returned and are doing their usual fine job.

There is a definite hope that we may find the way clear to construct a gymnasium-auditorium soon. It is needed very much, not merely for basketball, but for physical education for all pupils. The state law requires that physical education be a part of the curriculum. This has not been enforced in the past as so many schools had no facilities. It is probable that in the future the requirement for certification as a first class high school will include space set apart for such work. There is a bill in the present legislature which might have this effect if passed. Of course one of the reasons we want a gymnasium is to enable our teams to compete on a more even basis with surrounding schools, but that is not the prime reason for such a building. The reason we really need it is that it will benefit every child in school, and will also provide a community meeting place much better than any we have now. There is a chance that a bill now in the legislature would provide half the cost of approved school buildings. If this passes, it will be possible to put up a much better building than we could otherwise do.

We completed one major repair which has been needed for some time. This was painting both buildings. We also weatherstripped some 40 windows, repaired the roof of the high school building, installed a heating system in the Agriculture shop and made some repairs to the plumbing system. The overdraft of a little over a thousand dollars resulted from the fact that we had to change the heating system in the shop at a cost of over \$700.00, and the painting cost more than was estimated, due especially to the fact that the windows were in such bad shape. Most of the putty had to be removed and the windows reputtied, and there are a lot of windows. When the added cost became apparent, it was felt that a good job, with an overdraft, was preferable to a poor job within the cost allocated to the job.

We were fortunate in securing the services of Emmons Robinson to build up a band. This means a lot to the school, and to the town. There are many times and occasions when a band adds much to the program. It is hoped that this will be continued.

The attendance on the whole has been good. During potato picking and planting we have a number out. It is hoped that this can be kept to a minimum.

Mr. Payson's report covers the high school. The enrollment for the grades is as follows:

GREETING:

In the name of the State of Maine you are hereby required to notify and warn the Inhabitants of the Town of Island Falls, qualified by law to vote in Town affairs, to assemble at the Community Hall in said Town of Island Falls on Monday the twenty first day of March A. - Art. 5 To see what sum of money the Town will vote to grant and raise for the support of Common-School.
- Art. 6 To see what sum of money the Town will vote to grant and raise for the support of High School.
- Art. 7 To see what sum of money the Town will vote to grant and raise for the teaching of the vocational training in Agriculture.
- Art. 8 To see what sum of money the Town will vote to grant and raise for Text Books, Apparatus and supplies, and insurance on school buildings.
- Art. 9 To see what sum of money the Town will vote to grant and raise for a School Physician.
- Art. 10 To see what sum of money the Town will vote to grant and raise for repairs of school buildings.
- Art. 11 To see what sum of money the Town will vote to grant and raise for General Government as follows: Selectmen, Clerk, Treasurer, Collector of taxes, Town Manager, Health Officer, and all other necessary Town Officers and miscellaneous Town expenses.
- Art. 12 To see what sum of money the Town will vote to grant and raise for School Band.
- Art. 13 To see what sum of money the Town will vote to grant and raise for Hydrant Rentals.

- Art. 14 To see what sum of money the Town will vote to grant and raise for Street Lighting.
- Art. 15 To see what sum of money the Town will vote to grant and raise for the care of Cemeteries.
- Art. 16 To see what sum of money the Town will vote to grant and raise for the Anti-Tuberculosis Society.
- Art. 17 To see what sum of money the Town will vote to grant and raise for repairs of roads and bridges.
- Art. 18 To see what sum of money the Town will vote to grant and raise for snow removal.
- Art. 19 To see what sum of money the Town will vote to grant and raise for placing in position of snow fencing and removal of the same, and for the purpose of buying new snow fence.
- Art. 20 To see what sum of money the Town will raise and appropriate for State Aid Road Construction (in addition to the amount regularly raised for the care of ways, highways and bridges) under the provisions of Chapter 36, Sections 25 and 29 of the Revised Statutes of 1944 as amended.
- Art. 21 To see what sum of money the Town will vote to grant and raise for the support of poor.
- Art. 22 To see what sum of money the Town will vote to grant and raise for Aid to Dependent Children.

- Art. 23 To see if the Town will vote to grant and raise the sum of \$82.00 for public health nursing. The same to be expended by the Bureau of Health for local service.
- Art. 24 To see what sum of money the Town will vote to grant and raise for Town debt.
- Art. 25 To see what sum of money the Town will vote to grant and raise for interest.
- Art. 26 To see what sum of money the Town will vote to grant and raise for abatements and discounts.
- Art. 27 To see what sum of money the Town will vote to grant and raise for Town Dump.
- Art. 28 To see what sum of money the Town will vote to grant and raise for the Maine Publicity Bureau
- Art. 29 To see what sum of money the Town will vote to grant and raise for the Katahdin Public Library.
- Art. 30 To see what sum of money the Town will vote to grant and raise for Fire Department.
- Art. 31 To see if the Town will vote to fix a time when taxes are due and payable, and also to see if the Town will vote to allow a discount upon property taxes, paid at such time or times as it may determine, and if so, at what rate of per cent: also to see if the Town will vote to charge interest on all taxes if unpaid at such time as the Town may determine and to fix the rate per cent.

- Art. 32 To see if the Town will vote to grant and raise the sum of \$500.00 as a donation to the Milliken Memorial Hospital to be used by said Hospital for the construction, enlargement, and improvement of the Hospital facilities: Provided the other Towns adjacent to, and using said Hospital, shall donate a sum equal to 10 per cent of their valuations.
- Art. 33 To see if the Town will grant and raise a sum of money for the repair of the private road leading from Vaughan Walker's to the cottages on Pleasant Lake.
- Art. 34 To see if the Town will vote to collect garbage and dispose of the same, and to raise a sum of money for that purpose.
- Art. 35 To see if the Town will authorize the Selectmen to bring writs of entry for the recovery and possession of such real estate as has heretofore been acquired by the Town by non-payment of taxes and the time of redemption having expired.
- Art. 36 To see if the Town will vote to authorize the town treasurer under the written direction of all the Selectmen for such sums of money as said Selectmen may see fit to accept therefor, to sell and convey all right, title and interest in and to such parcels of land as the town has acquired by tax deeds or tax liens, and also to authorize the Town Treasurer to sign, execute, and deliver in the name and behalf of the Town deeds therefor.

- Art. 37 To see if the Town will vote to adopt Daylight Saving time.
- Art. 38 To see if the Town will vote to proceed in building an Auditorium for the use of the School, and for other Town purposes, and appoint a building committee for the purpose of carrying out the project.
- Art. 39 To see if the Selectmen and Town Treasurer for the purpose of building said Auditorium be authorized, to issue its bonds, or serial notes, of the Town for the sum of \$10,000.00 Said Bonds or notes to be dated July 1, 1949 and to be of the denomination of \$1,000.00 each payable \$1,000.00 on July 1st., 1950, and \$1,000.00 each year thereafterwards until said sum is fully paid. All of said Bonds or Notes to bear interest at the rate not exceeding 4 per cent, per annum, payable semiannually on the first day of July and the first day of January of each year. Said Bonds, if issued, shall be in coupon form and signed by the Selectmen and Town Treasurer. All other particulars as to form, issuance, and sale of said Bonds or Notes shall be determined by the Selectmen.
- Art. 40 To see if the Town will vote to have its collector settle in full for all taxes committed to him for collection on or before the 15th day of February, 1950
- Art. 41 To see if the Town will vote to ratify the doings of the Selectmen whereby they have abated certain taxes as appear in the Town report.

Art. 42 To see if the Town will vote to authorize the Selectmen to borrow as a temporary loan for the payment of debts contracted during the current year, and payable out of the taxes assessed for the current year. Said Selectmen is hereby authorized to sign, execute and deliver notes therefor, and to fix the amount and rate of interest therefor.

The Selectmen hereby give notice that they will be in session at said Community Hall on said 21st day of March 1949 at nine o'clock in the forenoon for the purpose of correcting the list of voters and hearing applications for the right to vote.
