

THE TOWN OF SKOWHEGAN IS PLEASED TO DEDICATE THIS YEAR'S TOWN REPORT TO RANDY GRAY

Randall D. Gray's dedication to the Town of Skowhegan has been exceeded only by the way in which he delivers it—with good natured respect. Randy can be tough when he has to be, but it's a rare person who has ever seen him when he didn't handle himself with grace during his nearly 39 years of service to the town as the Solid Waste Supervisor and Code Enforcement officer / building inspector.

Along the way, Randy has succeeded in adding many other hats to his already busy life and career. He has long been seen as the go-to person when it comes to matters of the Municipal Building, its upkeep and anything else that may come into play. Sometimes that has even included getting out of bed to respond to an alarm going off in the building during the night.

Meanwhile, as town managers have come and gone, on vacation or to seminars, it has always been Randy who has been called upon to take charge in their absences, using his extensive institutional knowledge to help run the town.

Randy, 65, knows the building codes and ordinances inside and out and applies them with honesty and integrity, while still respecting the people involved. Over the years, he has taken on a startling number of new building codes with ease and finesse.

In his own unpretentious way, without seeking glory or gratitude, Randy has created a composting program at the Skowhegan landfill that many see as a model for 21st Century environmental stewardship. At the same time it has saved the town thousands of dollars— in some years in excess of \$100,000.

Taxpayers are always at the forefront with Randy, who, with his team, oversees a composting program that produces up to 800 yards a year, free for residents. In 2015, Randy introduced a food scraps program to the town's tree and yard waste-disposal process, making a richer compost that's finding people eager to take his product. But the best part is, he shares all that credit with his crew. Randy oversees a team of five people at the town transfer station and award-winning recycling center and often acknowledges their input and ideas that have made the recycling system work better.



Cynthia Kirk, Randy's administrative assistant for seven years, said his rapport with his employees is next to none. "He really listens to his employees, whether it's me or the guys at the transfer station and really works to incorporate whatever ideas we have. He just really makes you feel validated for the work you do."

His composting program in 2015 received an award for Compost Program of the Year from the Maine Resource Recovery Association. In 2007, Skowhegan won the MRRA award for Recycling program of the year. Randy is acknowledged statewide for his skills, ability and attitude, according to Mark A. King, organic management specialist with the Maine Department of Environmental Protection. "He is one of the finest people I have ever worked with in my entire career with the Maine DEP," King said. "He is dependable, enthusiastic, and he is willing to do whatever it takes to get the job accomplished. His can-do attitude has made working with him probably one of the best pleasures of my career as a solid waste compost expert. He's an incredible guy. He leaves some shoes; it will take three people to fill them."




He also is admired by his fellow department heads as an honest and direct human being, according to Trisha L. Austin, Finance and Human Resource Director. "He is one of the most real people that I have ever met," Austin said. "As a friend, as a coworker, for the town—he's just really going to be deeply missed. He treats everyone with the utmost respect, no matter whether it's a resident, a department head or general worker. He cares what they think; he involves them in everything. He's irreplaceable



in the position he's in, not because he's a dear friend, but because of who he is and what he stands for—he is a good soul."

Randy grew up in Skowhegan, graduated from its high school and, other than a short stint of less than a year working for the City of Augusta, he hasn't really had another employer. Recently he received the 2019 Distinguished Service Award from Maine Resource Recovery Association at the Annual Maine Recycling and Solid Waste Conference. With family and town officials in attendance, Randy was also honored at the Maine Building Officials and Inspectors Association Annual Conference as the recipient of the 2019 Code Enforcement Officer of the Year Award.

Very much a family man, Randy's retirement plans include visiting his children and grandchildren in other states. He lives in Skowhegan with his wife, Rose and daughter, Olivia. Randy is a NASCAR fan and, in his spare time, loves to relax in his wood-working shop. It is there he crafts furniture, from blanket chests, to shelves, to headboards. Some are given as prized gifts and, in many cases, he has donated them for fundraisers.



Town Manager Christine Almand said Randy will be sorely missed. "As we begin our search for a new code enforcement officer, we know we will not be fortunate enough to find another Randy. He exemplifies all of the qualities of an excellent team member. Randy fulfills his enforcement role with experience and knowledge while being reasonable to gain cooperation. I receive more compliments than complaints for his service, and I believe that to be rare in his field. Randy will truly be missed."

The Boston Post Cane was awarded to Irene Marie Gallant Dumont on October 9, 2018 by Town Manager Christine Almand, Board of Selectmen Chairman Paul York, and Heritage Council Chairman Shirley Whittemore. Selectman Vanessa York was also on hand for the presentation. Irene was born in Keegan, Maine on August 23, 1917 and moved to Skowhegan when she was 14 years old. To help support her family, she worked at the Maine Spinning Company on the island. Irene was also a waitress at several local restaurants. A highlight for her was serving President Eisenhower during his visit in 1955.

In 1938, Irene married Eugene L. Dumont. She and Gene raised five children in Skowhegan. She enjoys weekly luncheons with a group of friends that call themselves the "Recycled Teenagers". She plays Bingo on Sundays, likes cheering on her favorite football team, the Patriots, and bets on her favorite horses. Irene proudly lives independently in a small apartment in Skowhegan.

The community joins the Quinn family in mourning the passing of Selectwoman Vanessa Lee on January 19, 2019. We lost a shining star who filled the dark spots in this world with her brilliant and winsome smile and good nature.

From the time the 48-year-old businesswoman took her seat at the table on the Board of Selectmen in June 2018, Vanessa began making an appearance at each opening of a new business, a forever champion of the people trying to enhance the town.

Always her own woman, Vanessa started training as a volunteer firefighter, but could not finish because she was afraid of heights and needed to climb the ladder on the truck,

according to her sister, Alicia. Vanessa loved her community, that's why she ran for selectwoman. She even took the time to do a ride-along with the police and highway departments to better understand their challenges and her work on behalf of her town. Vanessa was a proud member of many organizations, including the Skowhegan Regional Chamber of Commerce, the Redington Fairview General Hospital Board of Directors and the Order of the Eastern Star.



Vanessa named her vehicles. She had a truck named Dory because the color was Deep Ocean Blue. She owned an SUV name Coco after a hairdresser in New York and a car named Chad after the lead singer of Nickelback. Vanessa was a loyal Nickelback fan, traveling countrywide to see her favorite band.

Vanessa spent every waking moment of her life working with her sister, Alicia, under the watchful eye of their father, Thomas H. Quinn, at the Quinn Hardware family business. Alicia said she and Vanessa babysat in the office for the great nieces on days they called Little A Days. "She loved Little A Days, the only days she wasn't late to work", Alicia joked. It's rare when siblings can work well together, but Vanessa and her sister did it; they even took vacations together, Alicia said. At the top of her priority list, however, was her daughter, Emma Lee York, the light of her life.



Vanessa leaves behind a loving family, including her daughter, Emma; her sisters, Alicia and Jessica; three nieces and two great nieces, and her proud Mom, Lynda. She was predeceased by her Dad in November 2018.

Spirit of America Foundation Honoring Volunteerism Resolve of the Town of Skowhegan Board of Selectmen

The 2019 Town of Skowhegan, Maine Spirit of America Foundation Tribute honors Lynda Quinn for commendable community service.

Be it Resolved by the Town of Skowhegan Board of Selectmen as follows:

Whereas, Lynda Nutting Quinn personifies the meaning of volunteerism as presented by the Spirit of America.

Lynda, a lifelong resident of her central Maine community, is known for making things "work," with persistence and tenacity.

A member of the Bloomfield Trustees, she also is chairman of the Library Trustees for Skowhegan Free Public Library and a member of the fundraising committee. Lynda was among the active volunteers who devoted hours of service to making the \$1.5 million major renovation project at the 1890s library a reality, "all with donations and grants."

Lynda has always been dedicated to her town, spending 21 years as a selectwoman, nine years as its chairman, and says she has "loved every minute of it."

A graduate of Skowhegan High School and University of Maine at Farmington, Lynda has devoted nearly 40 years of her life to education. She taught at North Elementary for 17 years, Skowhegan Area High School Special Education for 12 years, and founded her own school, Somerset Valley Academy, which she operated for seven years.

More recently, she has served as a member of the SAD 54 school board for four years.

She also has been a member of the Daughters of the American Revolution for 35 years and a member of the Skowhegan Woman's Aid Society for six years.

She was, as a teenager, a member of Rainbow Girls Assembly 22, where she also later served as its Mother Advisor, and has been a member of Eastern Star for at least 40 years, currently serving as Worthy Matron of Minerva Order of Eastern Star Chapter 74.

Independent Auditor's Report

Board of Selectmen Town of Skowhegan, Maine

Report on the Financial Statements

We have audited the accompanying financial statements of the governmental activities, the discretely presented component unit, each major fund, and the aggregate remaining fund information of the Town of Skowhegan, Maine as of and for the year ended June 30, 2018, and the related notes to the financial statements, which collectively comprise the Town's basic financial statements as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express opinions on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions

Opinions

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, the discretely presented component unit, each major fund, and the aggregate remaining fund information of the Town of Skowhegan, Maine, as of June 30, 2018, and the respective changes in financial position thereof for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Other Matters

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis, budgetary comparison information and pension and OPEB information on pages 6 through 13 and page 48 through 53 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Other Information

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise the Town of Skowhegan, Maine's basic financial statements. The other supplementary information on Schedules 1 and 2 is presented for purposes of additional analysis and is not a required part of the financial statements. The schedule of expenditures of federal awards is presented for purposes of additional analysis as required by Title 2 U.S. Code of Federal Regulations (CFR) Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards, and is also not a required part of the basic financial statements.

The other supplementary information on Schedules 1 and 2 and the schedule of expenditures of federal awards are the responsibility of management and were derived from and relate directly to the underlying accounting and other records used to prepare the basic financial statements. Such information has been subjected to the auditing procedures applied in the audit of the basic financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, Schedules 1 and 2 and the schedule of expenditures of federal awards are fairly stated in all material respects in relation to the basic financial statements as a whole.

Other Reporting Required by Government Auditing Standards

In accordance with *Government Auditing Standards*, we have also issued our report dated March 29, 2019, on our consideration of the Town of Skowhegan, Maine's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is solely to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the effectiveness of the Town of Skowhegan, Maine's internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* in considering the Town of Skowhegan, Maine's internal control over financial reporting and compliance.

As your Town Manager, it is my pleasure and privilege to submit a report of the municipal activities by the various department heads, committees and organizations. The Town Report is a valuable resource of information and insight as to what is taking place in our community. You will find the June 2019 Annual Town Meeting Warrant located at the end of this Town Report.

For many years Skowhegan has used funds from the undesignated fund balance, also called surplus, for the sole purpose of reducing the tax commitment. At the 2018 Town Meeting, the voters also approved funding for future projects in the reserve accounts to come from surplus. In total \$1,418,000 of surplus was used for the following purposes: \$1,000,000 to reduce the tax commitment; \$300,000 towards the planned ballfield compound; \$100,000 for road improvements; and \$18,000 for rifles and a video camera system for a patrol vehicle for the Police Department. The 2019 Town Meeting Warrant will give voters another opportunity to set aside additional funding for future projects.

We are fortunate to have a staff that embodies the true sense of teamwork. Special Thanks and credit must be given to the Board of Selectmen: Paul York, Chairman; Gene Rouse, Vice Chairman; Betty Austin, and Roger Staples and to the Department Heads: Trisha Austin, Finance/Human Resource Director; David Bucknam, Police Chief; Brent Dickey, Pollution Control Plant Superintendent; Gregory Dore, Road Commissioner; Randall Gray, Code Enforcement Officer/Transfer Station Supervisor; Jeffrey Hewett, Economic and Community Development Director; Shawn Howard, Fire Chief; Denise LeBlanc, Parks and Recreation Director; Gail Pelotte, Town Clerk/Treasurer and William Van Tuinen, Contracted Assessor. Our group of dedicated department heads has a combination of over 200 years of service to the Town of Skowhegan.

The Board of Selectmen and the town encourage citizen involvement and appreciate when citizens become an active part of our governmental process. Dear Friends and Neighbors:

Let me begin by thanking you for the trust you have placed in me to be your voice in Augusta. It has been an honor serving as a State Representative over the last four years and I am humbled by the opportunity you have given me to represent you in the Maine Senate. I will continue to work tirelessly on your behalf, making sure your interests are heard and well represented in the Maine Legislature.

This past legislative session proved to be the longest in recent memory. After dealing with a number of major policy matters, we finally adjourned September 13.

Perhaps the most significant action the Legislature took last year was the passage of tax conformity. Failing to conform would have been a nightmare for businesses as well as for low-income and elderly Mainers. Maine would have lost \$37 million in one-time repatriated revenue. Due to the Legislature's actions and willingness to work together on the passage of tax conformity, Maine tax filers were unharmed by this policy change.

The 129th Legislature has many challenges of its own. The top priorities this session include finding a way to provide affordable and accessible healthcare to all Mainers, tackling the opioid crisis, education reform and funding, and lowering property taxes. I hope the Legislature can come together to tackle the difficult issues facing our state; and as always, I am ready to help.

Dear Friends,

It is an honor to represent Maine in the United States Senate. I am grateful for the trust the people of our state have placed in me and welcome this opportunity to share some key accomplishments from this past year.

As Chairman of the Senate Aging Committee, I worked to help ensure the well-being of our seniors. The *Senior\$afe Act* I authored became law last year and is empowering banks, credit unions, and other financial institutions to better protect seniors from financial fraud.

Following extensive committee investigations of prescription drug pricing, additional legislation I crafted became law, ending the egregious practice of pharmacy "gag clauses" that prevented pharmacists from informing patients on how to pay the lowest possible price.

This year, I was also successful in securing an extra \$425 million for Alzheimer's research—the largest funding increase ever—bringing the total to \$2.34 billion. Additionally, the bipartisan *BOLD Act* I authored will create public health infrastructure to combat Alzheimer's by promoting education, early diagnosis, and improved care management.

More than 40 million Americans—including 178,000 Mainers—are caregivers for parents, spouses, children, and other loved ones with disabilities or illnesses, such as Alzheimer's. The *RAISE Family Caregivers Act* I authored was signed into law last year, giving caregivers more resources and training to better balance the full-time job of caregiving. Another law I wrote will help grandparents who are raising grandchildren, largely due to the opioid addiction crisis.

In addition to helping seniors, a major accomplishment over the past year is the increased federal investment in biomedical research that is leading to progress in the fight against numerous devastating diseases. Congress has boosted funding for the National Institutes of Health by \$7 billion in just the last three years, bringing total funding to more than \$39 billion.

One of my highest priorities as Chairman of the Transportation Appropriations Subcommittee is to improve our nation's crumbling infrastructure and ensure that Maine's needs are addressed. Since the Better Utilizing Investments to Leverage Development (BUILD) Transportation Grants program, formerly known as TIGER, was established in 2009, I have secured \$160 million for vital transportation projects throughout Maine.

Congress also delivered a Farm Bill last year, which includes many important provisions that will help the agriculture industry in Maine and across the country. Specifically, I secured provisions that will strengthen support for young farmers, improve local farm-to-market efforts, and increase funding for organic research.

Congress took decisive action to address the opioid addiction epidemic. In addition to appropriating \$8.5 billion in federal funding last year, Congress enacted the *SUPPORT for Patients and Communities Act*, a comprehensive package that embraces the multipronged approach I have long advocated for this epidemic: prevention, treatment, recovery, and enforcement to stop drug trafficking.

Maine plays a key role in ensuring a strong national defense. In 2018, Congress provided funding for five ships to be built at Bath Iron Works, which will help to keep our nation safe and provide our skilled shipbuilders a steady job. I also secured more than \$162 million for infrastructure projects at Portsmouth Naval Shipyard to support their important work to overhaul Navy submarines.

A Maine value that always guides me is our unsurpassed work ethic. In December 2018, I cast my 6,834th consecutive vote, continuing my record of never missing a roll-call vote since my Senate service began in 1997.

Dear Friends,

As I travel Maine, I hear from people who live in every corner of our state. I hear about their achievements, their successes, their work to improve their communities – I hear about the hope they have for our state. I also hear about our challenges, and all the work we have left to do. As I see it, that's my job: to listen to you, act where I can to build on what's good, and work on the tough parts. As 2018 comes to a close, I wanted to take a moment to share an update on some of the work we're doing in Washington to lift up the accomplishments of Maine people and make progress on the challenges they face.

From Portland to Presque Isle, from Milo to Camden, I hear about the pain that the opioid epidemic is inflicting on Maine communities. I've met with Maine people in recovery, family members of those struggling with substance use disorders, treatment providers, and law enforcement officials to learn about their experiences with this terrible disease, and everyone agrees that in order to fully respond to these problems, we need a stronger federal effort to end the opioid epidemic. Fortunately, some help is on the way – in October, we overwhelmingly passed a sweeping, bipartisan opioids bill. I've pushed hard for this type of legislation and was proud to have provisions I've advocated for included in the bill. These priorities have been guided by the voices of Maine people, and we'll keep working to confront this tragic problem.

I've also worked to strengthen the future of our forest economy. Maine's forests have powered our state's economy for generations, especially in our rural communities. So, when rapid shifts in the market led to the closure of many pulp and paper mills and biomass power plants, it required a collaborative approach to support future growth in this important industry. That's why, together with the other members of the state's Congressional delegation, I pushed to establish the Economic Development Assessment Team (EDAT). This integrated, multiagency effort aims to foster innovation and commercialization in Maine's forest economy, and we're already seeing the benefits: in recent months, several forest industry businesses have announced significant investments into Maine operations, and in September 2018, the Forest Opportunity Roadmap (FOR)/Maine released an action plan to make sure this industry, and the rural communities it supports, can continue to thrive for generations to come.

As I close this letter, please allow me to express my gratitude to each of you – for your dedication to our state, and to one another. It's often said that Maine is like a big small town (with very long streets)—that's because at our heart, we're one big community. It's not only a pleasure to serve you—it's a pleasure to know you. Thank you for being the reason Maine is so special. Mary and I hope that 2019 will be a good year for you, your family, your community, and our great State.

Dear Citizens of Maine:

For the past eight years as your Governor, my priority has been to make Maine prosperous. I am proud to say that my administration has had some success, but there is more that can be done.

Mainers experienced strong, record-setting economic growth in 2018, setting so many new records: a record-high number of employers; a record-high number of private-sector jobs; record-high revenues for the state; record-low unemployment; and the fastest net-earnings growth in New England. Our poverty rate declined to the lowest since 2005 with the fewest number of children in poverty in 17 years. We must avoid letting politicians drive Maine's finances and its economy back into the ground. I promise you that I will be watching.

TAX COLLECTOR'S REPORT 2018

As Tax Collector, I am responsible for the collection and administration of property taxes for the Town of Skowhegan. Property tax is defined as any tax, fee, charge, or assessment imposed by any government entity upon property or a property owner as a direct consequence of being owner of that property. There are three types of property subject to taxes: real estate, personal property, and motor vehicle. All real estate within Maine, not exempted from taxation by Maine law, and most business personal property of Maine, is subject to taxation according to its status on the first day of April.

I would like to remind all tax payers that real estate and personal property taxes are paid twice a year, typically due on September 15th and March 15th. The installment dates for taxes to be due and the interest rate for delinquent taxes are determined by the voters at annual town meeting. It is the responsibility of the taxpayer to ensure that payment is made on time. Late payments will result in interest penalties.

The tax lien process for delinquent taxes must be commenced no later than one year from the date of commitment. A 30-day notice commences the tax lien mortgage process. The notice must be served after the expiration of eight months and within one year of the date of commitment. The tax lien could ultimately result in foreclosure if the taxes are not paid before the lien matures.

The Town of Skowhegan continues to offer a "Tax Club", and more people are taking advantage of the club each year. The Tax Club allows several monthly, interest-free payments for a taxpayer's primary and legal residence. All previous years' taxes must be paid in full before enrolling. Please note that late payments will cancel enrollment, and interest will be applied to the unpaid balance. The enrollment period begins after tax commitment which is typically in August or early September and ends a month later. Please contact the Clerk's Office located at 225 Water Street or by calling 474-6900 to enroll or for more information.

In closing, I'd like to thank all of the staff in the Clerk's Office for the often thankless work that they do to collect taxes. Special thanks and recognition go to the Town Clerk/Treasurer, Gail Pelotte for going above and beyond to work with taxpayers to get their accounts current.

TAXPAYER'S NOTICE

REAL ESTATE:

If you have constructed, altered or removed any buildings since April 1, 2018 and on or before April 1, 2019, please notify the Assessors' Office at 474-6903.

BUSINESS PERSONAL PROPERTY:

If you have started a new business, you need to notify the Assessors' Office to obtain forms for filing a list of your business furniture and equipment.

In accordance with Title 36, Section 706A of the Maine Revised Statutes, failure to furnish lists of taxable property or any of the aforementioned changes on or before the dates requested will bar one's right of an abatement of taxes.

EXEMPTIONS:

Taxation is the rule and exemption is the exception. If you think your property should have an exemption, and you are not already receiving it, you have an obligation to make the Assessors aware of the legal category of exemption the property may qualify for. All notifications and applications for exemption shall be made no later than April 1, 2020, for the 2020-2021 tax year. In the case of property owned by individuals, possible exemptions are for certain veterans, blind persons, and homestead owners as described below.

VETERANS:

All veterans who will be 62 years of age on or before April 1, 2020, any widow or minor children of veterans who would have been 62 years of age as of April 1, 2020 should contact the Assessors' office to see if they are eligible for a tax exemption. Any veteran who is receiving a 100% disability pension from the Veterans Administration should call to see if they are eligible for an exemption. Applications for veteran's exemption must be made with this office on or before April 1, 2020. If you are currently receiving a veteran's exemption, you do not need to reapply.

BLIND:

Any person who is declared blind by a Licensed Doctor should notify the Assessors' Office on or before April 1, 2020 to see if he or she is eligible for a tax exemption. If you are already receiving such an exemption, you do not need to reapply.

HOMESTEAD:

A person who owns his or her own home and has owned a home in Maine for at least 12 months prior to April 1, 2020 can apply for a Homestead Exemption. The application needs to be received by April 1, 2020. This exemption from taxation went into effect in 1998. We are assuming that it will be available in 2020 as well. One can only receive this exemption on the home that is his or her residence. If you are currently receiving this exemption, and you still reside in the same home, you do not need to reapply.

SKOWHEGAN BOARD OF ASSESSORS REPORT

To the Citizens and Taxpayers of Skowhegan:

The tax rate for the fiscal year 2019, beginning 7/1/2018 and ending 6/30/2019, was \$18.20 per thousand. That was a reduction of \$1.80 per thousand. The primary reason for the reduction was the substantial rebuild of a paper machine at Sappi. Even though such new business equipment is exempt from taxation, the State provides substantial reimbursement of the revenue such equipment would raise if taxable..

Skowhegan has a considerable industrial tax base. Major industrial accounts include the Sappi pulp and paper mill, the Weston Hydroelectric plant in the center of the town, and the Imerys precipated calcium carbonate plant located at the Sappi complex.

It was a pleasure to serve the Town of Skowhegan and we wish to thank the community for its cooperation and support.

As you are aware, your Skowhegan tax bill raises revenue for three levels of government. In the 2019 fiscal year the tax commitment in Skowhegan raised the following net amounts:

- 1. The town of Skowhegan raised a net amount of \$7,800,068. Included in this town amount is a Downtown TIF appropriation of \$81,669. This was about 24.4% of the total tax and amounted to about \$4.449 per thousand of valuation.
- 2. SAD 54 raised a net amount of \$9,296,531 which comprises 60% of the total tax and amounted to \$10.927 per thousand of valuation.
- 3. Somerset County raised a net amount of \$2,402,383.43 which comprises 15.5% of the total or \$2.824 per thousand.

The growth in the Skowhegan tax base over the past year included 19 new homes valued at \$1,740,900, two seasonal homes valued at \$65,800, and two mobile homes valued at \$75,500. We also saw a new commercial building valued at \$462,500.

Qualifying taxpayers who reside in a home as their primary residence and who have an application on record with this office continued to receive a homestead exemption from their taxable valuation. New property owners who reside in homes in Skowhegan need to file a homestead exemption by April 1. If you move from one home in Skowhegan to another, please call our office at 474-6903 to insure that we transfer your exemption to the new home.

Taxpayers are reminded that they have 185 days from the date of commitment of taxes to request an abatement of taxes in writing, if they believe that the valuation of their property is too high.

I would like to thank the citizens of Skowhegan for electing me to serve as Town Clerk and Treasurer.

The town's appropriation to S.A.D. #54 was nine million five hundred fifty-two thousand two hundred eighty-six dollars (\$9,552,286.00). The town's appropriation to Somerset County was two million five hundred forty-six thousand four hundred six dollars and ninety-three cents (\$2,546,406.93).

Higgins educational loans totaling nineteen thousand dollars (\$19,000.00) were issued to five graduates of Skowhegan Area High School's Class of 2017. Before making payments on their interest-free loans, recipients receive a one-year grace period upon completion of their education. Each year high school seniors have the opportunity to apply for a loan. A senior must contact the high school guidance office for an application between January and April 30 of their senior year. The application deadline is May 1.

I would like to take this opportunity to ask recipients of Higgins Loans that have not been making payments towards their loans to please begin making monthly payments. I have sent out several letters regarding

repayment of these loans and several go unanswered. Please make payments so that future students can have the same opportunity as you and receive an interest free loan.

To: Citizens of the Town of Skowhegan

The Skowhegan Fire Department responded to 708 calls for service in 2018.

In 2018 the citizens of Skowhegan voted not to fund a new Public Safety Building. While disappointing, it was understandable. The Committee has continued to work on a better solution. The fact remains that the Fire Station is 115 years old and needs to be replaced. The Committee has listened to the concerns of the voters and is determined to present a better proposal that addresses those concerns.

Like most Fire Departments across the nation, the Skowhegan Fire Department continues to struggle with a shortage of available firefighters. The average age of a firefighter in Skowhegan is 41 years old. The age groups are as follows;

5 Firefighters age 20-29

- 8 Firefighters age 30-39
- 8 Firefighters age 40-49
- 5 Firefighters age 50-59
- 2 Firefighters age 60+

The 28 Firefighters of the Skowhegan Fire Department have a combined 420 years of experience. Years of experience;

- 11 Firefighters 5 years or less
- 6 Firefighters 10-19 years
- 8 Firefighters 20-29 years
- 2 Firefighters 30-39 years
- 1 Firefighter 41 years

The average years of experience of a Skowhegan Firefighter is 15 years.

With more than half of the firefighters over the age of 40, the next decade could prove to be a turning point for the fire department. We must find ways to get young men and women interested in becoming call firefighters. Maine currently has proposed a program in Legislature to assist in providing incentives for call firefighters. The Length Of Service Award Program (LOSAP) will provide a type of monetary retirement program for Call and Volunteer Firefighters. This is just one step in addressing the shortage. We are at a critical point for the fire service. Call and Volunteer firefighter are the backbone of Maine Fire Departments. The best equipment, new stations, and bigger trucks will never replace the men and women of the fire service.

It is has been a busy year at the police department and I appreciate the support the citizens have shown us. When I first took this position, I stated how committed I was to this agency, the men and woman under my command and the citizens of Skowhegan. This has not changed and as we move into the New Year I can tell you this, we are just getting started.

There have been a few changes here at the police department. We have hired new officers and said "good luck" to others who have moved onto other agencies or occupations. I'm happy to say this issue of officers leaving has slowed down and I expect it to continue as we move forward.

Training as been a priority this year in which we have been able to certified officers as Instructors in various areas. Officer Boudreau became a Field Sobriety and Intoxilyzer Instructor, Officer Williams a Taser Instructor, SRO Daigneault and Deputy Chief Brian Gardiner are Active Shooter Instructors. Officer Damon graduated from the Police Academy and is back on the streets interacting with the community and leaving her trade mark quotes for local business checks. In addition, our officers have been instructing at the Maine Criminal Justice Academy and the Police Department has been hosting training courses which has brought officers from other agencies to our town.

In December, Brian Gardiner accepted the position as Deputy Chief and the Police Department has already benefitted from his motivation, ideas and commitment to this community. We also said goodbye to Administrative Assistant Kelly Woodard who is pursuing a career in the medical field. Her position was filled by local resident and retired Coast Guard Veteran Chief Nancy Weis. Nancy brings a plethora of experience which will be used in our daily operations.

Over the past year we have increased our community policing with officers working with our children in the schools. From the walking school bus program, snow shoeing and getting into snow ball fights during after school activities, the kids are starting to become more comfortable interacting with law enforcement. We hosted the first "National Night Out" in Coburn Park where we had law enforcement from all over Somerset County represented. CODE ENFORCEMENT REPORT July 1, 2017-June 30, 2018

To: The Board of Selectman and the Citizens of the Town of Skowhegan

From July 2017 through the end of June 2018, the Code Enforcement Department issued One hundred and forty-four (144) building permits, fifty-five (55) interior plumbing permits, twenty (20) septic system permits, twenty-one (21) Central Maine Power electrical forms, and sixteen (16) shoreland zone permits. The Town also issued eight (8) sewer capacity reserve permits.

The Maine Uniform Building and Energy Code (MUBEC) has been in effect for six full years now. Make sure that if you are planning any new construction, renovations or additions you contact the Code Enforcement Office before you start any work.

Our current Codes consists of a compilation of the following editions of the following codes:

2015 International Building Code (IBC); 2015 International Residential Code (IRC); 2009 International Energy Conservation Code (IECC); ASHRAE 62.1-2013 (Ventilation for Acceptable Indoor Air Quality); ASHRAE 62.2-2013 (Ventilation for Acceptable Indoor Air Quality in Low-Rise Residential Buildings); and ASHRAE 90.1-2013 (Energy Standard for Buildings except Low-Rise Residential Buildings).

Every year the Code Enforcement Office works with Department of Environmental Protection on land use violations. In some cases when violations are found, fines will need to be paid and consent agreements completed. Please remember to contact our office prior to the start of any land use construction and we will be glad to assist you with any and all permits needed for your project. I also want to remind everyone that if you are going to move any earth within 250 feet of any water body you are required to use an individual who is certified in erosion and sedimentation control.

Some of the new and relocated businesses in Skowhegan in the past year include: Wentworth Partners & Associates, Laney's Madison Ave., Pyro City, The Children's Center, Shelly's Toy Box and a portion of the 2nd floor of the Downtown Cornville Charter School.

The Fire Department and Code Enforcement Department continue to work together to inspect existing apartment buildings and businesses. Several of the buildings were made safer, by upgrading electrical, plumbing, heating systems, new fire escapes and egress windows.

The Code Enforcement Department is responsible for the enforcement of the Maine Uniform Building and Energy Code (MUBEC), State of Maine Plumbing Code, Shoreland Zoning Ordinance, Subdivision Standards, Floodplain Management Ordinance, Building Safety Ordinance, Site Plan Review Ordinance, Property Maintenance Ordinance and all State codes pertaining to unsafe buildings, building construction, and the Automobile Junkyard/Graveyard law.

As many of you know, I will be retiring from the Town of Skowhegan on June 14, 2019. I want to thank the town manager Christine Almand, the Board of Selectmen, all of the department heads, my Administrative Assistant Cynthia Kirk and all of the citizens of Skowhegan for supporting me throughout my career. I wish you all the best in the future.

WATER POLLUTION CONTROL PLANT 2017 - 2018 ANNUAL REPORT

To: The Board of Selectmen and the Citizens of Skowhegan

Work continued this year on the Phase 3 Combined Sewer Overflow Abatement project approved at the June 2013 Annual Town Meeting. Five sewer improvement projects funded by an \$11,880,000 bond issued by the State of Maine Revolving Loan Fund will be completed over a six year period to eliminate the discharge of raw sewage to the Kennebec River when the sewer collection system is overloaded by storm water. Olver Associates of Winterport, Maine updated the Town's CSO Master Plan in 2012 and was awarded the contract for design of the sewer improvements and administration and inspection services during each phase of construction.

The first phase of CSO work involved the replacement of the 41-year old Island Avenue pump station in 2014. The new pump station was completed by T Buck Construction of Auburn, Maine at a total cost of \$705,700. The new station has eliminated the frequent low volume CSO discharges that occurred with the old station and has greatly improved reliability.

A construction contract for Phase 3.2 sewer improvements on East Maple Street, Winter Street, Chandler Street, Dane Avenue, Bennett Avenue and Summer Street was signed in late June 2014 with Jordan Excavation of Kingfield, Maine for \$2,749,805.34. Work began in July and resumed in spring 2015 after a winter shutdown and was completed in November 2015.

T Buck Construction of Auburn, Maine was awarded the Phase 3.3 contract for work on Main Street, Willow Street, Green Street, Bailey Street, Bloomfield Street, Alder Street, Turner Avenue and a small portion of West Front Street in April 2015 for \$2,356,626.00. Work on this contract was completed in December 2015.

The fourth phase of CSO abatement work was bid in March 2016 and awarded to Sargent Corporation of Stillwater, Maine for \$1,993,360.00. The sanitary sewers on Mt. Pleasant Avenue, Olive Street, Ash Street and Center Street were replaced and a new separated storm drain was built on Mt. Pleasant Avenue. The so-called Joyce Valley Sewer, constructed in 1905, that runs through the valley between Mt. Pleasant Avenue and Milburn Street east to Joyce Street was converted to a storm drain. Construction began in June and was completed in November 2016.

Lou Silver Inc. of Veazie, Maine began the \$2,144,641.00 Phase 3.5 construction project in June 2017. Work to be performed includes re-lining or replacement of sewers on North Avenue between Jewett and Water Street and separation of storm drains from the sanitary sewers. A limited amount of sewer separation

work will also be done on lower Madison Avenue. Silver failed to complete the project by the contract deadline of November 27, 2017 and resumed construction in May after a winter shutdown. Silver's projected completion date is September 2018.

I would like to thank all the municipal departments for their assistance and support this year.

Any interested groups or individuals are encouraged to call us to arrange a tour of the wastewater treatment facility on Joyce Street.

Skowhegan Solid Waste Management Facility & Recycling Center Report July 1, 2017-June 30, 2018

To: The Board of Selectman and the Citizens of the Town of Skowhegan

Our existing composting and food scraps program is continuing to grow and be a success. We have now partnered with the Cornville Charter Schools here in Skowhegan. They are collecting their food scraps which we in turn add to our compost. The food scraps have made a big improvement to our already impressive composting program. For the past 2 years now, we have worked with the Skowhegan Rotary and collected all of the shells and food scraps from their annual lobster bake. We also encourage all residents to sign up for the food scrap program. We will even provide you with a bucket for your food scraps collecting. By continuing to grow this program it has the potential to save the taxpayers even more **thousands** of dollars per year. Since we have continued to be able to produce such a large amount of compost over the years, we are going to be able to sell between 500-600 cubic yards of compost to contractors this coming year and still have plenty of free compost for our residents!

With the rising costs of trash disposal and the decrease in revenues being paid for recyclables, it is imperative now more than ever that the Town of Skowhegan increases its efforts to recycle in 2019. Increased recycling efforts will help to keep disposal costs down which in turn will help keep our local taxes down. The Town continues to work with all the local schools to increase their recycling efforts. We also offer and conduct recycling education instruction to area schools, groups and small businesses as well as at our annual Open House. Anyone interested in this recycling education program should contact Cynthia Kirk at 474-6904. The Solid Waste Management Facility is open daily Tuesday through Saturday from 7am to 3:45 pm, with extended summer hours on Tuesdays and Thursdays until 4:45pm.

The amount of revenues generated at the Solid Waste Management Facility for July 1, 2017- June 30, 2018 totaled \$106,857.00. This includes the sale of all recycled materials, sticker fees and universal waste/bulky waste fees. The Recycling Center processed 627 tons of cardboard, newspaper, mixed paper, metal, plastics, glass and 50 tons of material was sold or reused from the transfer station. If this material were not recycled the town would have spent an additional \$53, 817.00 in landfill tipping and hauling fees to dispose of the product. The recycling efforts of the community have resulted in a total savings of over \$173,095.00 from July 2016–June 2017. This savings includes both the sale of the recycled material and the avoidance of landfill tipping and hauling fees. **Have you recycled today?**

From July 2017-June 2018, the Transfer Station handled over 6,758.52 tons of municipal solid waste, construction demolition debris and other material disposed of through our transfer station and by commercial haulers at a cost of over \$464,000 in landfill tipping fees to the Town of Skowhegan tax payers. The Town also spent \$18,206.00 for the disposal of construction demolition chipped wood and clean wood, along with over 456 tires at a cost of \$855.00. The average household in the Town of Skowhegan disposes of 1500 pounds of trash per year. It is extremely important for all households to recycle more to help do their part to reduce the cost of trash disposal landfill tipping fees.

Our newest permit stickers will be available for sale in September 2019. They are valid from January 1, 2020 through December 31, 2021. The cost of a permit sticker is \$10 each and are available at the Town Office and the Solid Waste Facility. This biannual sticker system helps to ensure that only Skowhegan residents are disposing waste at the Skowhegan Solid Waste Management Facility. **The Town of Skowhegan Solid Waste Management Ordinance states** that the Solid Waste permit sticker shall be attached and displayed on the vehicle that it is issued to only.

As many of you know, I will be retiring on June 14, 2019. I would like to thank the Skowhegan citizens and businesses for their efforts to recycle as much as possible over the years. I also want to thank my staff Clyde Merrill, Steven Foss, Al (Furnie) White, James Travers, Tom Smith and Cynthia Kirk, Administrative Assistant at the Solid Waste Management Facility for their dedication and hard work operating a very successful recycling program. I know they will continue to work hard for our citizens even after I am gone.

We continually strive to provide wise guidance to the Selectmen concerning needed ordinances and policies, while at the same time recognizing the various rights and freedoms, especially the property rights, of the Town's residents. To the Citizens of the Town of Skowhegan:

2018 has been a very busy year for the office, we have been working on a large variety of projects such as the new Façade Grant to the Downtown TIF applications. We are always looking for different projects to help improve our Town and welcome any input from the public.

One of the projects we worked on was the 2018 Town-wide Façade Grant Program; which we received \$100,000. We are now working with 15 applicants who are planning on improving their business building facades. For every dollar that is granted to the business, the business has to match at a minimum of one dollar. There is already a waiting list for the next façade program.

The office has been in discussions of an energy reduction project. One of the major discussions we have been working on is converting the existing streetlights from Non-LED to LED lights. To do that the Town will have to purchase the lights and then pay for the conversion to LED. This discussion lead to the Town putting out an RFQ (Request for Qualifications) for a company to work with the Town to do a major Energy Reduction Project. The Selectmen decided to work with Siemens Industry, Inc.; to look at streetlight conversions, energy reductions for the Municipal Building, Community Center, Pollution Control, and the Highway Building.

The office worked with the new Downtown TIF Committee on one application for funding to assist in building improvements.

SEDC has reviewed and approved two RLF Loans for this year. If any business would like information regarding one of our loan programs, please contact the office at (207) 474-6905 or by email to jhewett@skowhegan.org.

SEDC has also sold two lots in Southgate to Civil Arms; who has built a 1.4 million-dollar facility on one of the lots purchased. We were able to work with Beeline Cable Company to supply Civil Arms with high speed internet as needed. With the improvements that Beeline has done in the park, we are now able to offer high speed connectivity to existing and future companies in the Southgate Industrial Park.

Annual report to the selectmen and citizens of the town of Skowhegan:

This past year has been a transition year for the conservation commission. With the conclusion of the multi-year Whitten and Cold brooks water quality monitoring program, we looked to explore new opportunities to engage with the community. To that end, the commission sponsored The Marti Stevens School's "Invasive Species Carnival", collaborating with The State of Maine's Department of Agriculture, Conservation and Forestry, the Skowhegan Recreation Center, Marti-Stevens School students and faculty, as well as members of our community. Our intent will be to continue to seek out on educational opportunities that engage students, faculty and the community.

For the past several years the Conservation Commission members and volunteers have provided upkeep and maintenance of the Yankee Woodlot Trail located behind the University of Maine Cooperative Extension office on Norridgewock Avenue. We will look to be involved with this work again in the near future.

Further, we amended our meeting schedule from meeting once per month, to a bi-annual meeting schedule; meeting every six months, adding additional meetings as needed based on events and/or request.

This past year the commission saw three of our member's terms expire, resulting in two vacancies, as one of those members chose to serve for another term. We also added one new member to the commission. Bob McGorty, previously acting-Chair, and Tristen Hinkle were voted in as Chairman and Vice-Chairman respectively.

Main Street Skowhegan (MSS) is a 501(c)(3) nonprofit focused on the ongoing revitalization of Skowhegan. In 2015 we expanded our purview to include the entire town—not just the downtown—enabling us to serve all Skowhegan businesses and implement town-wide projects. Our mission is to grow a vibrant and inviting historic town by encouraging innovation and economic development. We spearhead collaborative efforts to support businesses and diversify the economy, stimulate tourism, and tell Skowhegan's story.

Economic Development Initiatives (July 1, 2017 through June 30, 2018)

Brought A New Business to Skowhegan via the Main Street Skowhegan Savings Entrepreneur Challenge

In partnership with Skowhegan Savings Bank, the MSS Business Enhancement Committee coordinated five business-planning seminars and mentored nine entrepreneurs. The winner of the 2017-18 Entrepreneur Challenge was Amanda Leigh Clark, LCSW and her business River Trail Counseling & Wellness Center. Amanda was awarded a \$23,000 incentive package, which she used to open her business in the summer of 2018.

Coordinated a Shop Local Event on Small Business Saturday

MSS planned and executed the third annual Passport to Savings Program on November 25, 2017, Small Business Saturday. Incentivized by merchant discounts and incentives, shoppers made 787 purchases at 44 participating businesses located all over Skowhegan.

Started the #ShopSkowhegan Incentive Program

MSS kicked off a year-round shop local program that is free and open to any Skowhegan business. For each purchase made at a participating local business, patrons can sign up to win a \$25 gift card.

Continued to Promote and Support Locally Owned Skowhegan Businesses

Tourism Product Development Initiatives (July 1, 2017 through June 30, 2018)

Raised \$40,000 for the Run of River Whitewater Recreation Area

In partnership with the Run of River Committee, MSS was awarded \$40,000 in grant funding for Run of River. Funds were used to complete project next steps, including required pre-permitting tasks. MSS continues to develop and foster relationships with potential donors and apply for applicable project grants.

Brought 6,000 People to Town for the Skowhegan Moose Festival

The MSS Moose Festival Committee planned and executed a successful weekend of activities around the Maine Moose Permit Lottery in June 2018. The event drew record-breaking attendance—an estimated 6,000 people—to Skowhegan to celebrate recreation and outdoor heritage sports. Visitors stayed, shopped, and ate at local businesses, and more than 1,000 attendees participated in a Guinness-World-Record-breaking moose call!

Hosted 400 Cyclists During BikeMaine Ride

MSS coordinated BikeMaine's September 2017 visit to Skowhegan, where the ride both started and ended. Our volunteers served riders meals, handled luggage and parking, and provided information about Skowhegan and the region. The event brought 400 bicyclists from 35 states and 5 countries to Skowhegan.

Skowhegan Free Public Library

Some major changes have taken place at the library this past year. Our previous Director, Dale, has stepped down and the Board of Trustees have restructured the existing staff. We now have three full time staff members: Angie who is the new Head Librarian—she has merged her youth services responsibilities with all of the administrative duties; Josie covers the computer lab and genealogy room as the new Technology Librarian; and Breanna is the new Adult Services librarian on the main floor. There are also two part-time librarians: Francoise has been moved back upstairs to the middle office area where she is in charge of all interlibrary loans, and Linda was hired on as the Library Aid/Substitute.

Another major change is now that the renovations are over and we have this big beautiful building, we are working on providing more services and community events to get the public in and involved with the library. Gone are the days of being book repositories or quiet, musty buildings with nothing but rows of books. Instead, we want to serve a broader scope and be a community cultural center. Thanks to a donation made by the Hight family, we now have a beautiful reading room on the third floor. This room has been used by teens on their laptops, kids playing games, adults knitting and talking, a few quiet meetings, and some homework. It is a versatile space that is used for so much more than reading. We need more of these spaces that can be used for meetings, collaboration, studying, and just "hanging out."

Programming is a big focus for us currently. In 2018, we held 184 programs that saw 2638 people in attendance. These programs have ranged from story times, book clubs, craft sessions, author talks, game nights, art shows, guest speakers, and even a public paranormal investigation. The library also received a Maine Public Library Fund grant of \$1300 to purchase robots and iPads to create a Robotics and Coding Club that will start in the fall and \$500 from the Friends of the Library to purchase new board games to add to our collection for families to borrow.

On behalf of the Board of Trustees of the Skowhegan History House Museum & Research Center, thank you Skowhegan citizens for your financial support for the work we do. We invite you to visit the History House to enjoy its 18th and 19th century period furnishings, tools, documents, art work, Civil War memorabilia, toys, special exhibits, objects of everyday life, and more - all of which have provenance to

our community. The Museum is on the National Register of Historic Places.

History House staff, volunteers, Board members, and guest presenters strive to highlight our community's cultural heritage. We showcase an historic House with an attached Museum as well as offer on-site and community-based programs, activities, and exhibits. Seasonally, we offer Curator guided House and Museum tours to elementary, high school and college students - as well as to local, regional, state-wide, national, and international visitors. We offer assistance to researchers and genealogists seeking their family histories. Our technology enhances both on-site exhibits and guided walking tours of four designated Skowhegan Historic areas. Additionally, we offer school-based local history programs for elementary classes and themed community-based programs during our off-season.

The Historic Home Registry Program issued thirteen plaques for Skowhegan homes and buildings which are at least one hundred years old. Of these 13 sites, three are over 200 years old! Please call us (465-7458) for more information about this program.

We are grateful for continued support from Skowhegan citizens, dedicated funds from the Bloomfield Academy Trust, revenues generated from our Society memberships, private donations, and our Annual Appeal. Because of your financial support the Board of Trustees was able to implement significant improvements to the historic 1839 building during the 2018 season. (See listing in box on the right).

Our Trustees continue to be concerned with the lack of on-site and off-site space for appropriate archival storage and collection displays. A major goal for History House over the next 7 years includes working with other Skowhegan organizations to expand off-site archival storage so that we will have the physical space needed to create more exhibits that further explore our cultural heritage.

2018 Projects & Events

- Opened a new two year exhibit (Shoe Shops); offered four Historic Tours, presented two programs ("Exploring Notable Local Writers" & A Discussion of Early Photography & Errors in Family Histories.
- Awarded a \$10,000 Davis Family Foundation grant to restore six cellar windows systems & three museum windows. Secured a \$5,140 CDBG Façade Grant to restore the remaining five Museum windows.
- Awarded a \$3,000 Community
 Foundation Grant for a French drain
 system designed to halt water
 infiltration into the north side of the
 History House cellar.
- Regraded the eastside step system to comply with ADA standardized stair tread size; installed a new handrail.
- Created audio/video tours of second floor exhibits as well as outdoor exhibits/signage to comply with ADA regulations, making these areas accessible to handicapped visitors.
- Accepted The Independent Reporter (1910-1930's) and Somerset Reporter newspapers (dating back to the 1800's) from the Norway Advertiser Democrat.
- Partnered with Maine State Library (MSL) to scan, digitize, and OCR (optical character recognition) these newspapers, which then, uploaded to the MSL on-line digital site and to the History House website, make them available to the public at no cost.

The expenses for operating History House May - October (five

days a week, Monday – Friday) with a part time curatorial staff member and a student intern continue to increase, like those of other institutions and businesses. The Board continually searches for dedicated

volunteers, for partnerships, and grants, as well as additional memberships and donations to fund its Student Intern Program and on-going program development.

We gratefully thank the following businesses for their donations: Randy Frank for plumbing services, S&K Heating for heating oil, and Econo Electric for electrical services. We thank Hight Chevrolet Buick, Bangor Savings Bank, Franklin Savings Bank, Pat & Norman Dickey along with other private citizens and businesses, who wish to remain anonymous, for their continued partnerships and donations. These

donors make it possible for the Board to improve programming, fund the Student Intern program, and meet goals that renew and refresh the appeal of History House in this everchanging world.

We are also thankful for the loyal core of supporters who give of their time and energy to volunteer at History House. Their invaluable contributions include collection protection and special project tasks, technology support, and cataloguing as well as landscape and Heirloom Garden maintenance. We could not function without them.

and to make such assurances, assume such responsibilities and exercise such authority as are necessary and reasonable to implement such programs with the understanding that should the intended National Objective of the CDBG program not be met, all CDBG funds must be repaid to the State of Maine CDBG program. (The Selectmen recommend passage of this article.)

ARTICLE 59. To see if the Town will vote to appropriate all of the money received from the State for snowmobile registrations to the Skowhegan Sno-Hawks Snowmobile Club for the maintenance of their system or network of snowmobile trails, on the condition that those trails be open in snow season to the public for outdoor recreation purposes at no charge, and to authorize the Board of Selectmen to enter into an agreement with the Club, under such terms and conditions as the Board of Selectmen may deem advisable, for that purpose. (The Selectmen recommend passage of this article.)

- <u>ARTICLE 60.</u> To see if the Town will vote to authorize the Board of Selectmen to dispose of by the most prudent means possible, any equipment, vehicles, furniture or other non-real estate town property that is no longer necessary to town operations. (The Selectmen recommend passage of this article.)
- <u>ARTICLE 61.</u> To see if the Town will vote to authorize the Board of Selectmen, on behalf of the town, to sell and dispose of any real estate acquired by the town for non-payment of taxes due thereon, on such terms as they deem advisable and to issue quit claim deeds for such property. (The Selectmen recommend passage of this article.)
- <u>ARTICLE 62</u>. To see if the Town will vote to adopt the amended Budget and Finance Committee By-laws. Last amended at Town Meeting February 14, 2012. (The Selectmen recommend passage of this article.)
- <u>ARTICLE 63</u>. To see if the Town will vote to adopt the amended Parades and Processions Ordinance. Adopted at Town Meeting March 8, 1999. (The Selectmen recommend passage of this article.)
- ARTICLE 64. To see if the Town will vote to adopt the amended Special Amusement Ordinance. Last amended at Town Meeting June 11, 2018. (The Selectmen recommend passage of this article.)
- ARTICLE 65. To see if the Town will vote to repeal the Adult Entertainment Businesses Ordinance (adopted December 11, 2006) and the Establishing Community Standards and Regulating Commerce in Obscene Material, Obscene Devices and Obscene Performances Ordinance (adopted November 5, 1996) and to replace them with the Obscenity and Adult Entertainment Ordinance. (The Selectmen recommend passage of this article.)
- ARTICLE 66. To see if the Town will vote to authorize the Board of Selectmen to purchase a piece of property, located at 11 Main Street (Map 23, Lot 52) from Dale and Nancy Kinney for an amount not to exceed \$15,000.00 from the Sale of Town-Owned Property Account. (The Selectmen recommend passage of this article.)
- <u>ARTICLE 67</u>. To see if the Town will vote to approve a ten-year lease agreement between the Town of Skowhegan and Lily Pond Farm LLC for lease of the land where the sludge building is located (Map 2, Lot 11). (The Selectmen recommend passage of this article.)

ARTICLE 68. To see if the Town, pursuant to the provisions of Title 30-A, Maine Revised Statutes, Chapter 3 (Municipal Affordable Housing Development District), will vote to Authorize the adoption of the Mary Street Affordable Housing District Development Program, the establishment of the "KVCAP Mary Street Affordable Housing Development District" located at 26 Mary Street (Skowhegan Tax Map 8, Lot 52B-4) as shown in said Development Program, the entering into an Affordable Housing Development Program Tax Increment Credit Enhancement Agreement with KVCAP or its designated successor, the terms of which shall be consistent with the provisions of the aforesaid Affordable Housing District Development Program, and to authorize the Board of Selectmen and the Town Manager to prepare and file an application with the Maine State Housing Authority for approval of the aforesaid Affordable Housing District Development Program. (The Selectmen recommend passage of this article.)

The Registrar will hold hours for the purpose of revising and correcting the list of voters on Thursday, June 6, 2019 and Friday, June 7, 2019 from noon to 4:00 P.M.; Monday, June 10, 2019 from noon to 4:00 P.M. and from 6:30 P.M. to the close of the Town Meeting and Tuesday, June 11, 2019 from 7:00 A.M. to close of polls at 8:00 P.M.
