DEDICATION

The Somerville Town Report is dedicated this year to Ernestine Peaslee who is leaving public service after serving as Town Clerk for the past 22 years. We will all miss her smiling presence at the Town Office, but know that she will remain an active member of Somerville organizations and activities.

Ernestine Peaslee is part of a long tradition of service to the Town of Somerville; her sister also served the town as Town Clerk. Ernestine was born in Somerville, and has lived all her life here, except for 15 years during which time she lived in Augusta.

She is descended from the Robbins family who were featured in the book 'Come Spring', a story of the first settlers in Union, Maine. Ernestine's family moved to Somerville several generations ago. Their homestead is located on the east side of the Sheepscot River, near Turner Ridge Road on Route 105, which has long been considered the center of town. She has numerous relatives still living in the surrounding area, though she considers all of the townspeople her adopted family.

She attended school at the Somerville School which is now on display at the Windsor Fairgrounds. Upon graduating from Somerville School, Ernestine attended and graduated from Erskine Academy. She then attended Gates Business College in Augusta.

While still a student Ernestine went to work at Augusta Federal Savings, where she continued to work for the next 32 years. Upon her retirement from the bank, she worked in a variety of jobs before making the decision in 1991 to run for the office of Town Clerk/Administrative Assistant for Somerville.

Over the years, she has recorded the many births, deaths, and marriages of the residents of Somerville, watching families grow up and the town change. Ernestine could always be counted on to help out when needed. As the Registrar of Voters, Ernestine has overseen Federal, State, and town elections, ensuring efficient and fair elections.

Ernestine has been a member of the Somerville Volunteer Fire Department Ladies' Auxiliary for over 40 years, and is a founding member of the Somerville Days Committee, serving in various positions in both of those groups. She is an active member of the Whitefield Lion's Club, the Sand Hill Cemetery Association, and the Maine Town and City Clerks Association. Ernestine also served as the Treasurer for the Somerville Voluntary Fire Department for many years. She is a faithful Christian and serving member of the South Somerville Baptist Church. Ernestine was part of a mission to Haiti for two weeks, and is active in the Dorcas Women's Group of the Baptist Church.

She enjoys traveling around the State, particularly along the coast, exploring new areas and sharing her love of this State with all of her friends. She is a born caregiver and has cared for many persons in the community. Her particularly favorite hobby is painting, creating beautiful landscapes that she shares with her family and friends.

While looking forward to having the time to paint and spend time with friends, Ernestine is anticipating keeping busy and involved in the town, and finding new endeavors to keep her occupied.

We hope you will join us on April 6 at the Town Office from 2:00 -4:00 p.m. to celebrate Ernestine's devoted service to our Town.

REMEMBRANCE

In recognition of the loss of two respected members of our community, we ask for a moment to celebrate the lives of Orrin Crummett and Cecil Brann.

Orrin Crummett passed away on January 11, 2013. He was born and raised in Somerville, and became very active in town affairs. He served as a selectman for the town of Somerville for many years, was fire chief of the Somerville Volunteer Fire Department, served on the Somerville Planning Board, and was a member of the Somerville School board and the Sand Hill Cemetery Association.

Cecil Brann passed away on January 24, 2013 at his home on Crummett Mountain Road. He was born and raised in Somerville, and was a very active member of the community. Cecil and his wife, Virginia, sponsored a scholarship fund that recognizes graduating 8th graders from Somerville. They also donated 250 acres to the Small Woodland Owners Association of Maine, which is to be maintained as a working forest and a tree farm, and is open to the public.

Though they are no longer with us, their contributions to the town of Somerville will long be remembered.

In accordance with Title 36 M.R.S.A. Sec. 706, as amended, the Assessors of the Municipality of Somerville hereby give notice to all persons liable to taxation in said municipality that they will be in session at the Somerville Town Office, 72 Sand Hill Road, in said municipality on the 2nd day of April, 2013, at 6:00 p.m. for the purpose of revising lists of the estates taxable in said municipality.

OWNERS

All persons liable to taxation in the Municipality of Somerville, Maine, and all Personal Representatives, Trustees, etc. of all estates taxable in said municipality of such persons are hereby notified to furnish to the Assessors TRUE AND PERFECT LISTS OF ALL THEIR ESTATES, REAL AND PERSONAL, not by law exempt from taxation, of which they were possessed on the first day of April, 2013, and be prepared to make oath to the truth of the same and to answer all proper inquiries in writing as to the nature, situation, and value to their property liable to be taxed.

Addressing Officer's Report

Upon starting this position, I found data and information to be scattered. With assistance from State resources, a neighboring town addressing officer, and manuals, I was able to get an overview of where we need to be and how to get there. I was unable to ascertain where the database that produced the existing list of names and addresses was created and stored.

Some time ago, a database template was sent to town offices from the State when 9-1-1 conversion occurred. Because Somerville did not opt in, we did not receive it. I obtained that template from a neighboring town and have begun entering information to it on the town laptop computer where everything should be centralized.

To make sure all existing information is accurate from this point forward, I will be meeting with the Postmaster (whom I have contacted) to compare data so that all who rely on it have consistently correct information.

During the last three months of 2012, one new address request was received and processed. Time spent on these tasks and research was approximately 18 hours. I plan to continue work toward a clear and consistent procedure for information gathering, updating and processing to ensure that all work product is accurate, consistent, and accessible.

Deputy ACO for the year of 2012 was called out on 3 calls, all resulting in dropping animals off at the County Shelter in Edgecomb.

Somerville Emergency Management Agency

2012 was a quiet year in Somerville in the emergency management arena. We were not hit hard from any storms.

In order for Somerville to maintain its National Incident Management System compliance (and be eligible for FEMA grants), our town officers who have a direct role in emergency management must complete the NIMS IS -700 executive level training. This training was hosted by the town of Nobleboro and taught by instructors from Lincoln County Emergency Management Agency. Susan Greer, Martha Staples, Gerry Kimball, and Ernestine Peaslee attended this training.

As part of the Lincoln Hazardous Mitigation Plan, each town is required to have several town officials trained in the Hazardous Mitigation Grants Program. This program provides a percentage of total Disaster Assistance funds for mitigation measures to be implemented during the immediate recovery efforts after a disaster. This training was provided by the Maine Emergency Management Agency Hazard Mitigation Officer. Mike Dostie, Jesse Turner, Susan Greer and David Greer attended this training.

If you need assistance during a storm or other emergency event please call 911 which will dispatch the appropriate response team to you. If you have any damage to your property or buildings during a declared disaster, we can assist you in completing the forms needed to receive FEMA assistance.

General Assistance Officer's Report – 2012

To the Residents and Officials of the Town of Somerville:

To date, this year has been a particularly tough year for some Somerville residents. Just since July 15, 2012, the town has received ten (10) distinct requests for General Assistance (GA). Of these, five were found to be "in-need" by State definition, three were deemed emergency requests, and one request was voluntarily withdrawn.

Please be aware that Somerville General Assistance funds are limited and a safety net when Somerville residents truly need them. Stringent State laws must be followed when distributing GA funds. An application attesting to financial status, along with supporting documentation is required. A complete application must be submitted to the General Assistance Officer for consideration, unless a need is considered an emergency by State definition.

Somerville says “Thank You” to the Lincoln County Regional Planning Commission for awarding, through their new ASK (Assistance with Specific Know-How) Program, \$2000 to match the Town of Somerville’s funding for engineering services to develop a five-year long-range road improvement and maintenance plan. Somerville’s Road Assessment, Inventory, and Planning Project is well under way and will present their draft plan at Somerville’s Spring 2013 Town Meeting.

Somerville’s Role in American Grantmaking:

The value of gratitude and appreciation cannot be overstated. Every year many municipal, county, state, and federal agencies earmark funds to support projects and assist with a vast array of needs and efforts that organizations like the Town of Somerville determine to focus on. It is important to understand our role in applying for these funds as meeting community needs and providing the opportunities they are intended for.

Beyond governmental resources, more than \$346 Billion (dollars) is given away by private individuals, foundations, and corporations every year. Of these, 76,000 private foundations award more than \$44B annually. Grantmaking enables them to give something back to the community. By law, foundations must give away 5% of their market value assets. By applying for grants, we play an important role in America’s system of charitable giving and community development.

Tax Mapping Report

During the first part of the year work on the tax mapping project was somewhat stalled, so the Board of Selectmen and I talked about the options for going forward. We contacted Bill Duffy, from Northern Geomatics, who had provided some early assistance with the software the Town had purchased. Mr. Duffy does the tax maps for Newcastle, Hallowell, and unincorporated areas, and has some history with the Town of Somerville. We were able to negotiate the first draft of the tax maps using the remainder of the funds that had been reserved for tax mapping in 2011.

With deeds, maps, and surveys from the townspeople and Lincoln County archives, Mr. Duffy was able to deliver the draft tax maps to the Town in December. 430 lots have been completed, with clear deeds and surveys available; another 80 properties have been tentatively outlined, due to vague property descriptions being available; the remaining 20 properties still need documentation and verification.

The tax maps are available for property owners' review and mark-up. Please take the time to review your property and provide any additional documents to the Town. The plan is to provide the mark-ups to Mr. Duffy so he can deliver a final set of maps by this summer. Once we have the tax maps, we will be able to ensure our tax rolls are accurate and up to date.

We also lost Cecil Brann who was also a life member for 47 years and continued to support and attend all of our fire suppers. They will both be missed by all.

Unfortunately we suffered a lot of damage to our equipment during the fire on Crummett Mountain Road due to the extreme cold which froze up all of our trucks. I would like to thank everyone in town who supported these events. A special thanks to Martha Staples who organized the Modern Woodman's matching fund drive for \$2,500, which brought our fundraising total to \$6,266.45.

Sheepscot Valley Conservation Association



The Sheepscot Valley Conservation Association, based in Newcastle, crossed a major threshold in 2012 when it achieved accreditation from the Land Trust Accreditation Commission, an independent program of the nationwide Land Trust Alliance. This distinction is the result of a three-year effort by the board and staff to review and update the operations of the Association and demonstrate that SVCA complies with national standards for land trusts. SVCA is one of only 181 U.S. land trusts, and one of only 7 in Maine, to be awarded accreditation since the fall of 2008.

Another major event of note in 2012 was Executive Director Maureen Hoffman's announcement that she would retire at the end of the year. Maureen took up the position in January 2002, and much of SVCA's expansion, both in protected properties and role in the community, has occurred during her tenure. She is being replaced by Steve Patton, who has worked for The Nature Conservancy for 22 years. The President of SVCA's board of directors, Honor Fox Sage, also stepped down in 2012 and has been replaced by John Atwood, a retired Maine Superior Court judge who before being appointed to that position held a number of high-level positions in the Maine state government.

SVCA was founded in 1969 to both conserve land and advocate for the environment. This was, and still is, an unusual combination of goals for a land trust in Maine to adopt. SVCA has done so successfully, demonstrating its ability to identify conservation goals and carry them out while simultaneously being a voice for conservation in local issues.

That said, land conservation is SVCA's primary mission. The Association has worked with many conservation-minded landowners to protect 15 miles of riverfront and 3,569 acres of working farms, forests and important habitat in over 50 conservation properties, including seven preserves open to the public for low-impact recreation including hunting and fishing. In 2012, SVCA welcomed the donation of a conservation easement on 66 acres in Alna. SVCA also has joined with neighboring land trusts in a number of collaborative conservation projects including the River-Link effort to link the Damariscotta and Sheepscot Rivers and existing public preserves in Newcastle, Edgecomb and Boothbay.

Most recently, the SVCA has been a leader of the new 12 Rivers Conservation Initiative, a group of 10 local land trusts seeking to accelerate conservation of the forested landscape from the Kennebec to the St. George to achieve a network of conserved lands that protects the Midcoast's ecosystems and ensures multiple human benefits for generations to come.

SVCA maintains seven of its properties as preserves open to the public:

Palermo Preserve, with one mile of interpretive trail, on the upper stretch of the Sheepscot;

Whitefield Salmon Preserve, along the confluence of the west branch and the main stem of the Sheepscot, with nearly two miles of trails;

Stetser Preserve, in Jefferson, with 150 wooded acres and a 1.5-mile loop trail;

Trout Brook Preserve, in Alna, protecting over 4,200 feet of the brook, frontage on the Sheepscot, with a half-mile loop trail and the new one-mile Hoffman Trail;

Bass Falls Preserve, in Alna, with one mile of Sheepscot River frontage and three trail miles;

Griggs Preserve, in Newcastle, with two miles of trails through hilly woodlands;

Marsh River Preserve, in Newcastle, with over one mile of frontage on the Marsh River and two miles of trails including an interpretive trail.

SVCA's Water Quality Monitoring program completed its 19th year. Volunteers sampled test sites throughout the watershed every other week during the summer and investigated one of the tributaries in depth. The data collected helps guide not only SVCA's river-protection efforts but also those of the Maine Department of Environmental Protection and the former Atlantic Salmon Commission, now a part of the Bureau of Sea-Run Fisheries and Habitat.

SVCA is hosting the Sheepscot Valley Family Festival on Sunday, September 8, 2013 at its headquarters and the Newcastle Community Center on Sheepscot Road. There will be a 5k fun run (the Salmon Run) as well as guided paddles on the river, live animal demonstrations, live music, food and more. It will give the greater communities of the Sheepscot River Valley a chance to come together to celebrate the river and its abundant resources. We hope to see you there.

SVCA also organizes numerous nature hikes and canoe trips in the watershed throughout the year, open to all. See our website for more details. There are many other ways to join the fun, including opportunities to assist in trail maintenance, preserve stewardship, easement monitoring and other volunteer activities.

Damariscotta Lake Watershed Association

Land Protection

DLWA staff and volunteers continued to maintain public trails on the West Branch and Davis Stream Preserves in 2012. On the former, in particular, significant beaver activity, combined with aging bridgework, led to a trail work initiative this fall which resulted in four new bog bridges, new erosion control steps on steep grades, and several trail re-routes around areas which are now flooded. DLWA joined the regional Wednesday Walkers group in leading public nature walks on these trails, which are open for many uses in various seasons, ranging from hunting to skiing to hiking. Trail maps are available at DLWA's lakefront office at 38 Lake Farm Circle in Jefferson and on our website: www.dlwa.org.

DLWA completed one conservation easement in 2012, protecting a small parcel with lakefront shoreline as well as shoreline along a small tributary feeding into the lake in the West Narrows area. This land will remain undeveloped as a buffer to protect lake water quality. Donors of conservation easements give up certain development rights while maintaining ownership of their properties. DLWA currently owns almost 500 acres of undeveloped land and hold conservation easements on over 600 acres in the watershed.

Educational Programs

Classroom presentations at both the Nobleboro Central School and Washington's Prescott Elementary about watershed protection culminated in 6th grade students from these schools participating in a Water Wonder Day ecology field trip at Wavus Camp in Jefferson.

DLWA also hosted educational presentations and programs throughout the year for the general public at its office and in the field, on topics ranging from native pollinator conservation to timber harvesting to animal observation and tracking.

DLWA also ran a third summer of youth sailing camp in collaboration with the CLC YMCA, offering week-long sailing instruction and games to about 30 students.

Hooked on Fishing

At the Damariscotta Lake State Park in early June, DLWA hosted its third annual youth fishing event in collaboration with many local and regional partners. Around 40 children came out for the event, despite an impending rainstorm in the afternoon, joining experienced local fishermen in hour-long outings on the lake and enjoying lunch provided by the Whitefield Lions Club.

Water Quality Monitoring

The regular bi-weekly volunteer program of water clarity and dissolved oxygen measurement was continued during the 2012 season in all three of the Damariscotta Lake's basins. Oxygen levels in the Great Bay continued to become depressed in the late summer and were severely depleted in both Muscongus Bay and the South Arm, but were within historical norms. Water quality of Damariscotta Lake remains about average when compared to other Maine lakes.

Invasive Plants

DLWA continued to rely heavily on volunteer efforts in a three-pronged defense against invasive aquatic weeds. In 2009 and again in 2011, the Damariscotta Lake was threatened by infestations of the invasive aquatic plant hydrilla, an aggressive weed which can reduce property values, boating/swimming opportunities, and native wildlife habitat. Every year since, DLWA has coordinated a shoreline survey for additional infestation sites. This year, volunteers and staff were able to cover about 58% of the lake shoreline, finding no new locations of plants.

In the late winter, the DEP successfully finished a rip-rap wall which has isolated the Cranberry Cove infestation site from the rest of the lake, making it much less likely to spread from this location. Treatment and removal at this site is on-going.

DLWA, in conjunction with the DEP, began an aggressive weekly monitoring and hand removal effort at the second infestation site on the Davis Stream tributary, keeping the plant growth at this location in check.

Meanwhile, Courtesy Boat inspectors at the Route 213 public boat launch inspected close to 1,100 boats entering and leaving the Damariscotta Lake, making sure that no invasive plants were being carried out or carried in on propellers, trailers, or fishing gear. No invasive plant fragments were found this year.

DLWA also held regular identification workshops and trainings to help teach residents what to look for in their own areas.

Much of this work was made possible by grants from the DEP, contributions from individual members and municipalities and, of course, is contingent upon the many volunteer hours put in by watershed residents. Thank you to everyone who helped out!

2012 Service Report - Somerville

Delta is pleased to be able to continue providing emergency Paramedic response to the people of your community and to support your First Response Rescue at no cost to the community.

As a not-for-profit organization, we fund our operations solely by reimbursement for patient calls directly from the patient and the patient's insurance policy. This is possible in large part due to our economy of scale. We write off approximately 28% of our care annually as charitable giving to the uninsured and underinsured and support of special community events.

In 2012, we responded to 30 911-calls. Of these, 5 calls were for assistance from patients who did not require hospital care. These patients were evaluated by our paramedics and received no invoice. Additionally, we also serve your community by regularly providing non-emergency care and transfer services for patients.

Our average response times, the time between our receipt of the call and our arrival, for delivery of paramedic care was 17.4 minutes for emergencies.

Paramedic care is the highest level of Pre-Hospital care available. Our Paramedics exceed State Standards for recertification and respond with the latest medical technology available including 12 lead EKG and pharmaceutical interventions. Our care is reviewed in our Continuing Quality Improvement (CQI) program, which is recognized as a leading process in Maine.

Our support for your Rescue Services includes the offer of continuing medical/rescue education and on scene replacement of used medical supplies at no cost.

Dear Citizens of Somerville,

It is my pleasure to send greetings to you! As the Interim Superintendent for Sheepscot Valley RSU #12 this year, it has been my great pleasure to visit all the schools and to meet and work with the principal, staff and students. This year has seen a major change in the Somerville Elementary School as it changed from a classroom building, to the central office for the RSU as well as the site for the Special Education offices, the northern Alternative Education program (connected to Wiscasset High School), and the Technology office. This space is ideal for all the work required to maintain our schools and remains a comfortable learning environment for our Alternative Education students.

The Somerville students from grades K-8 are now all attending Windsor Elementary School. Mr. Rob Moody and the staff have made a very welcoming learning environment for your students. All staff at Windsor Elementary School have been working closely together to provide the very best educational opportunity for each and every student. Patricia Watts, the Assistant Superintendent and Curriculum Director, has also worked carefully with the administrators and staff to begin the work of developing clearly focused curriculum, instruction and assessment. During the year, she has had the opportunity to add a literacy coach who is working within the system to provide leadership and support in reading and writing for grades K-2. Several teachers at Windsor are also receiving Reading Recovery training with Mona Schlein. That training provides strong reading support for students in the first grade and also connects to their daily work in reading and writing.

Under Rob Moody's strong leadership, the focus on the education – academic, social and emotional – has been of primary importance. Through strong curriculum development and assessment, the learning environment for each student is demonstrating careful review of instruction, use of data to determine specific instructional needs, and adoption of programs that reflect on grade level appropriate planning. As more clearly defined expectations are developed for all students in the RSU, we also must seriously work on the staff development necessary to encourage and help develop strong, independent learners.

Safety is a great concern for the students as well as the staff. Rob has lead in planning Windsor's Emergency Safety Plan. Following the very sad events at Sandy Hook in Connecticut, there has been serious work in the area of the physical plant and what is needed to provide immediate protection. The parents at Windsor Elementary School should be proud of fact that the building has very important facility changes in place.

Finances for RSU #12 continue to be affected by the current economy. The RSU is not expecting increased state revenue and our revenues from Medicaid reimbursements have all but disappeared. With that in mind, while also reflecting on the academic, social and emotional needs of many of our students, we are spending a great deal of time reviewing the current budget requests and determining what can and must be recommended in the new budget to meet student needs. Each administrator has also worked diligently on three year planning that carefully reflects the changes that need to be considered for our students. The FY 2013 budget is \$26 million dollars. This is significantly less than collective spending in FY 2009. However we are constantly monitoring all areas of the budget and have, at this point, frozen spending, except where absolutely necessary, in preparation for curtailment from the state and added expenses based on the TIF grant, Special Education placements, and continued needs in the area of educational programs.

Some educational highlights include:

- Involvement in the “Maine Schools of Excellence” initiative, a federal program that focuses on top quality teachers and leader evaluation, with strong support in for performance feedback and professional development to improve instructional practice;
- Utilizing the Response to Intervention (RTI) model to enhance student success in math, reading and writing;
- Continuing implementation of the Accelerated Reader and Accelerated Mathematics Programs that builds excitement in the areas of reading, writing and mathematics;
- Strong parent and extended family support for these programs; and
- Reviewing the potential benefits of developing “customized” learning plans for all students.

RSU #12 remains dedicated to providing high quality programming which manage the fiscal responsibilities of the communities involved. The cost sharing plan passed in November will also result in some significant savings for the towns in the RSU. Your Somerville representatives to the RSU #12 School Board are Mr. Frank Hample and Senator Christopher Johnson. The RSU #12 School Board meets at 6:30 P.M. at various school sites, on the second Thursday of each month. As always, the public is invited to attend. Public comment is a part of each and every agenda.

We are pleased to have the opportunity to provide our residents with information about the Adult Education program. If you should have any questions regarding this information, please Call: 549-4687 and ask to speak to Debra Randall.



Attention Communities Members:

Are you Equipped for the Future? Did you leave high school without a diploma? Call the Adult Education Program and get started on your GED. We provide classes that will upgrade existing skills, provide career counseling, and improve reading and math skills. All it will take is a phone call to: 549-4687. Start the year out on the right foot. Call now and ask to speak to Deb Randall.

Adult Basic Education (ABE): a program to help assist students with improving their reading and math skills. A student is given a CASAS test to determine reading and math levels for proper course level placement. Students are required to address short and long term goals and what they are willing to do to obtain those goals, i.e., attend one or two nights per week, study for a pre-determined amount of time per week, and complete all homework assignments. At the end of each semester students are given a post-test to mark improvement. At this time goals are revisited to determine if they were accomplished or if modifications are required. In many cases a student who wants to eventually do their GED will start out in our ABE class because their reading and or math levels are to low. As soon as their levels are

up enough to enter the GED program we make that transition.

General Education Development (G.E.D.): a State Equivalency Test that has five parts to it.

Test #1-Language Arts, Writing
Test #2-Social Studies
Test #3-Science
Test #4-Language Arts, Reading
Test #5-Mathematics

A student interested in the GED is given a pre-test. This is a mini version of the actual test to determine if they had taken the real test, would they have successfully completed it. If their scores are fine then we schedule them for the actual test. If, however, the student's pre-test scores indicate that they need work in any of the five content areas, we set them up with tutorial until those skills are mastered.

We are very pleased to let you know the GED program is alive and well. We have had many students who have completed and gone on to the following: college, technical school, cosmetology schools, the military, culinary arts school, promotions on existing jobs and first time employment for many others. In June we will celebrate our 22nd graduation.

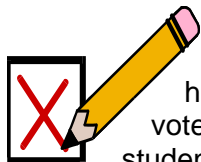

program and make arrangements to complete what you started.



The Adult Ed. Program is a voter registration site. We have many students register to vote for the first time. Many students express apprehension about the process so we set up a mock election and take them through the process. We then use this exercise for material in our math classes to determine percentages and compare those percentages to actual outcomes. They all enjoyed this exercise and feel more comfortable with the procedure of voting.

Vocational Courses: We are limited in this area because we do not have a high school to work from, however, we do the best we can with what we have. We offer computer courses, CPR, notary public, food service training, custodian training, substitute teacher training,

College Courses: Through an articulation agreement with Kennebec Valley Community College we offer three to four free college courses each semester, English Composition- (101), College Algebra-MAS (117), Medical Terminology- MAS (121), Intro to Psychology- PSY (101) and Soc 101. Application forms must be completed and an assessment test is required. Tuition is free; however, students are responsible for book and or college activity fees. Call 549-4687 if you are interested in becoming a part of our College Transitions Program.

Accuplacer Testing: the Accuplacer test is the test given as a college entrance exam. This test can be administered right at the Adult Education Office followed by counseling sessions to interpret the test results, financial aid assistance and scheduling college visits.

College Transition

In response to the need for developmental and college prep courses as a bridge program leading to college, these classes are designed for high school graduates or GED recipients who intend to apply to post-secondary institutions. Successful completion will avoid the need to take basic developmental courses at the postsecondary level and expending their financial aid resources. Registration is free; however students must pay a \$30.00 non-refundable book deposit.

Family Literacy: Through the Capital Area Adult Education Consortium we have a small amount of money to put towards family literacy. We will be actively recruiting children and parents from Headstart Programs and parents of those children enrolled in our schools under



Title I. Our focus will be parents with children ages 0-8 years of age. Book bags with material for our Adult Education students and their children will go home to promote reading and family interaction.

Personal enrichment: Courses such as zumba, crafts, quilting, fly tying, etc., are self-sustaining.


To The Residents of Somerville, Maine:

Dear Residents,

It has been an honor for me to manage the TCSWMO Transfer and Recycling facility for the past 20 years. During this time, with the continued guidance of a dedicated Board of Directors, TCSW has established itself as both forward thinking and fiscally prudent. Our recycling rate, for the most part, has remained over 40% since we opened in '92. We have more often than not been among the first to recycle difficult items such as computers, televisions, fluorescent lamps, poly-coated papers, & 1 and 3-7 plastics. This has all been accomplished while managing a budget over all these years with no shocking peaks and valleys in assessment to the tax base and only one increase in bag fees.

As I mentioned last year, the PERC incinerator, where we send our trash, is preparing for the end of a very beneficial electricity sales contract with Bangor Hydro in 2018. Along with the usual tipping fee increases, (this year we will see \$78 per ton) we will also begin to see the results of diminishing returns on our performance credits. Up until now, these credits amounted to about \$25,000 to us. By no later than 2018, that value will be zero. Coupled with increased hauling costs, the need for a new trailer, as well as the need to be able to participate fully in the next long term solution for our waste disposal needs, it is unavoidable that we increase revenue to meet increased costs. Rather than increasing our assessment on the tax base, which has been held steady for many years, it is the philosophy of the Board of Directors to put this modest increase where people can still affect it the most: on the bag fee. As of April 1, 2013, the bag price at TCSW will rise to \$1.50. While this may seem high to some, it is still at the low end for pay as you throw programs around the State.

You can still very much minimize your costs at Tri-County by recycling. Numbers aren't in yet, but it appears that this year our recycling rate as a community has dropped below 40% for the first time. It isn't as though our recycling opportunities have diminished; in fact, they have grown with the introduction of a fuller spectrum of plastics including rigid and bulky plastics. Opportunity exists for most people to recycle another 20%. If this is achieved, overall costs for trash disposal would actually drop. Please pick up a listing of recyclable material at our facility and please ask staff for any further clarification.

Lastly, please remember our annual Household Hazardous Waste (HHW) Collection Day on the third Saturday of June. This is a good opportunity to be rid of the partially used hazardous chemicals so many of us keep in our basements and garages. Keep your eyes peeled for posters and fliers at the transfer station well in advance of the collection day.

As is always the case, please feel free to address any questions regarding general transfer station operations to myself or to our well seasoned and perhaps overly salted crew: Hank, Russ, David, and Jeff. Thank you for your time, care and consideration.

Please continue to recycle as it truly saves all of us money, energy, natural resources and more!

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Somerville, qualified by law to vote in Town affairs, to meet at the Town Office located at 72 Sand Hill Road, the Twenty-Ninth day of March, 2013, at 2:45 p.m. to act on the following Articles, to wit:

ARTICLE 1: To choose, by written ballot, a moderator to preside at said meeting.

ARTICLE 2: To choose, by secret ballot, in accordance with the vote of the Town, the following officers and officials: Three Selectmen, Assessors and Overseers of the Poor; one Town Clerk/Administrative Assistant; one Tax Collector; one Treasurer; one Road Commissioner (2 year term).

THE POLLS WILL BE OPENED AT 3:00 P.M. AND WILL BE CLOSED AT 7:00 P.M.

Pursuant to Title 21-A, Section 759(7), absentee ballots will be processed at the polls at 7:00 p.m.

AT 9:00 A.M. ON THE THIRTIETH DAY OF MARCH, 2013, IN THE GYM AT THE RSU 12 OFFICES LOCATED AT 665 PATRICKTOWN ROAD, CONSIDERATION OF THE FOLLOWING ARTICLES WILL BEGIN.

ARTICLE 3: Cause the Town Clerk/Administrative Assistant to be Appointed. To see if the town will vote to change the Somerville Town Clerk/Administrative Assistant position from an elected to an appointed three year term position to become effective in the year when the current official's term ends, and to authorize the Board of Selectmen to appoint a qualified person to serve in this position. If approved, this provision shall remain in effect until repealed or replaced by voters at a future town meeting.

ARTICLE 4: Cause the Town Treasurer to be Appointed. To see if the town will vote to change the Somerville Treasurer position from an elected to an appointed three year term position to become effective in the year when the current official's term ends, and to authorize the Board of Selectmen to appoint a qualified person to serve in this position. If approved, this provision shall remain in effect until repealed or replaced by voters at a future town meeting.

ARTICLE 5: Change the terms of the Board of Selectmen from one year to three year staggered terms. To see if the town will vote to change the terms of the Board of Selectmen from one year to three years, staggered.

Explanation: Beginning in 2014 the First Selectmen would be elected for 1 year; the Second Selectman elected for 2 years; and the Third Selectmen elected for 3 years. In 2015, the First Selectman will be elected for a 3 year term. In 2016, the Second Selectmen will be elected for a 3 year term. In 2017, the Third Selectman will be elected for a 3 year term, and continuing the cycle there from.

ARTICLE 6: Administration Purposes. To see what sums of money the town will vote to raise and/or appropriate from property taxation for Town administration. Budget Committee recommends \$28,187.50. Board of Selectmen recommend \$28,200.00.

ARTICLE 26: Allows distribution of funds from snowmobile registrations. To see if the town will vote to appropriate the funds that are received from the State of Maine in 2013 and 2014, from snowmobile registrations, to the Backwoods Bouncers Snowmobile Club for the purpose of maintaining their snowmobile trails, to be open to the use of the public at all times, excluding the use of ATVs without landowner permission, and shall the Selectmen be authorized to enter into an agreement with the Club under such conditions as the Selectmen may deem advisable, for that purpose?

The Registrar of Voters will be at the Somerville Town Office on the day of said meeting, namely March 29, 2013, at 2:30 p.m. for the purpose of correcting the list of voters.
