There is included elsewhere in this Town Report a copy of a survey of school buildings, made by a representative of the State Department of Education. That report adequately describes the school building situation in the Town, and I refer all readers to it. I am in accord with the statements made. and hope that the citizens of the Town will find it

possible to remedy a bad situation by providing ways and means to build new school facilities.

The Maine School Building Authority R. S., C. 37, Secs. 212-228 provide an opportunity for this Town (together with other Towns) to build a school building with aid from the State as provided in the Act.

Sec 213 of the law reads as follows: "Purpose. A general diffusion of the advantages of education being essential to the preservation of the rights and liberties of the people; to aid in the provision of public school buildings in the state, the "Maine School Building Authority," herein created is hereby authorized and empowered to construct, acquire, alter or improve public school buildings and to issue revenue bonds of the Authority, payable from rentals to finance such buildings and when paid for by said rentals to convey them to the lessee towns.

The project must be approved by the Maine School Building Authority and by the Town after preliminary request has been made by the School Committee and the Selectmen.

A School Building Committee appointed by the Town, it so authorized, would have full authority to prepare plans. If and when the project is approved by the Authority and the Town, said Committee would proceed with the necessary details to have the building constructed.

The need for a new building is obvious to all persons, even to those remotely connected with the schools. The proposition offered by the State to aid in financing the building is so unusual that any Town in need of new facilities should take advantage of the opportunity.

I wish to thank all persons connected with the schools for their continued co-operation.

### NORTH KENNEBUNKPORT SCHOOL REPORT

In order that the townspeople may be thoroughly familiar with the school conditions existing in the Town of North Kennebunkport, and be ready to take the necessary steps to remedy these conditions, the School Committee has authorized the publication of the "Report of Investigation of the School Housing Situation in North Kennebunkport" which was made by Mr. William O. Bailey of the State Department of Education.

#### REPORT OF INVESTIGATION OF THE SCHOOL HOUSING SITUATION IN NORTH KENNEBUNKPORT

Any consideration of a school housing problem must take into action some of the modern trends in elementary education.

No longer is the one-room rural school, that housed all grades, considered adequate. When first established, it provided the only available means of offering a program of public education to the youth residing in sparsely settled areas. Improvements in highways and modes of travel have made it no longer necessary to maintain schools within walking distances of every home. Pupils can now be transported to and from school just as their parents commute considerable distances to and from their employment. This is resulting in the development of larger school units where:

(1) teachers can do better work because they have fewer grades and more time with each grade.

(2) the school building can be developed into more than a series of boxlike classrooms and can include facilities such as a "general purpose" room for play, for assembly and cafeteria purposes, and a clinic room for use in connection with the health program.

(3) modern conveniences such as central heat, running water, flush toilets, etc., can be provided at a reasonable cost.

(4) larger groups of pupils of the same age can live and develop together physically, intellectually and socially.

(5) services supplementing the 3 R's can be economically offered to further enrich the generally accepted fundamentals of the elementary school program. Music, art, school lunch, physical examination, etc., are becoming an accepted part of the elementary school program.

Since 1946 more than 40 towns in Maine have recognized the advantages of larger school units to the end that they have constructed new consolidated elementary school buildings.

### SCHOOL BUILDINGS IN NORTH KENNEBUNKPORT

My investigation of the school buildings now in use revealed that there has been no new construction for nearly 50 years. Four of the five buildings in use this past year are typical, old, one-room rural schools that must be considered obsolete in terms of housing a modern educational program. None of them has been renovated to include the modern conveniences which are common in the children's homes. The two-room Burnham School is no better.

#### SANITATION:

Toilet facilities of the privy type as provided in all the buildings are unsatisfactory at best. Where used by a small family in an ordinary home, they may be considered reasonably "satisfactory" if suitably maintained. However, when used in a school building by 20 to 35 pupils, it is impossible to keep them in a sanitary condition. At certain seasons of the year, toilet odors are bound to permeate the entire building. During that time of the year when privy toilets should receive the most attention, it is difficult if not impossible to keep them clean because of our climatic conditions.

The absence of running water in these buildings makes it difficult to encourage cleanliness. When water for drinking and washing purposes has to be brought to the building in containers, only a minimum amount is usually available.

The installation of oil-burning space heaters in the school buildings of North Kennebunkport has probably improved the heating situation considerably. However, in these old structures where there is no heat beneath the floors and some of the foundations are in poor condition, I should expect the floors to be cold and drafty during the winter months. This is not conducive to a good health.

#### DURELL SCHOOL:

This typical old one-room, rural school has been housing all eight grades. The playground is small, but the interior of the building appears to be in good repair. New movable pupil furniture has been installed. The classroom is approximately 22 feet square, therefore, it is of sufficient size to house about 16 to 18 pupils.

#### IRVING SCHOOL:

This one-room rural school which I understand is not to be used next year housed 11 pupils in all grades last year. The playground is very small; the classroom itself is only sufficiently large to hold 14 or 15 children. Natural lighting is of the bi-

lateral type which has not been considered acceptable for many years. Only two lighting fixtures provide the artificial lighting. This classroom is heated by means of a box stove which has not been jacketed, so one must assume that the heating will be very uneven. When this building was visited, the classroom was unbearable because of the privy toilet odors. Furniture in this classroom is of the old type, very dark in color and light absorbing. The classroom has only one exit.

### NORTH CHAPEL SCHOOL:

This one-room school was constructed in 1867 and has been housing 32 pupils in all grades. The classroom is generally Clark and gloomy and the modern oil-burning space heater is installed adjacent to the only exit. This classroom has windows on three sides of it with the result that seeing conditions for the children housed there are undesirable because of cross lighting, glares, etc. This classroom is of sufficient size to house only approximately 22 pupils under modern school building standards.

### IRON BRIDGE SCHOOL:

This one-room school building contains a classroom which is only about 19 feet square. It is lighted on three sides, Dark and dingy. There is no provision for ventilation and the four reasonably good semi-indirect lighting fixtures can not be expected to produce satisfactory illumination because of the environmental conditions. This classroom should be housing not more than 12 or 13 pupils instead of the 26 that were enrolled there last year. The playground is poor, ledge crops out in many places which renders much of the limited area very undesirable for play purposes. Here again there is only one exit.

### BURNHAM SCHOOL:

This two-classroom building which was constructed in 1868 includes two small classrooms housing about 28 pupils in each.

The lower grades room should be housing some less than 20 pupils. It has poor natural lighting and no ventilation. The privies for use of the pupils in this room are connected with the classroom by a single ventilated passageway. State law requires that there shall be a separate ventilated passageway for each sex. The upper grades room has been re-decorated recently but it is very similar to the lower grades room, but a little larger-in size. Natural lighting and the ventilation are both inadequate.

This building is located adjacent to the railroad tracks and there is no fence between the playground and this hazard. The site is estimated to be considerably less than one acre in area. Ledge crops out on the playground near the building. A cursory examination indicated that at least part of the sills of the building had started to decay. The stone foundation in at least one place tips in and is in need of general repair.

### CONCLUSION

Because of the type of school organization now in existence in North Kennebunkport, it would be difficult and expensive, if not impossible, to provide the type of instructional program together with the additional services that a consolidated school is able to offer. Continued expenditures to modernize, expand and improve the existing school buildings can never result in a really efficient modern educational system in North Kennebunkport. If the 151 pupils now enrolled in the elementary schools could attend a central building, five teachers would provide an adequate teaching staff,

The ultimate school organization in North Kennebunkport should consist of one central elementary school building housing all pupils and all grades.

### RECOMMENDATIONS:

1. That a new school plant be planned that will accommodate the entire elementary school population of North Kennebunkport: it should consist of a minimum of 5 classrooms, a general purpose room, and clinic and teachers' room.
2. That it be so designed that it can be expanded if the occasion demands.
3. That it be located on a site of 5 to 7 acres in size and so planned that a general purpose room for the school and community use can be constructed as a part of the plant. If this appears impossible at the present time, it should be planned central location.
4. That immediate steps be taken to procure this site in a for some future date.

Since this report was made on June 28<sup>th</sup> 1951, the State Building Authority was passed, which makes it possible for towns in need of new school buildings to borrow the funds from the State and to pay the amount back in the way of rent until the entire sum shall have been repaid. An application for such funds for the use of North Kennebunkport for

the purpose of building a new school has been made by the School Committee and signed by them and by the Selectmen, and has been received by the State Building Authority for consideration.

### ANNUAL REPORT—PUBLIC HEALTH NURSE, 1951

Let us look back over the last five years to find out what has been accomplished since May, 1947 when the public health nursing service was made available to the citizens of North Kennebunkport.

One of the first activities was to organize a Health Council to better interpret the public health program to the community. Through the interest and support of this group the school health program was expanded to include physical examinations for children in grades one, three, five, seven. Under this plan a child would get four physical examinations during his school life.

Invitations were extended to all parents to accompany their children for those examinations so that there would be better interpretation of the findings. The response has not been too encouraging. During the five year period eighty-two children were examined and only eighteen parents were present for these examinations.

Follow-up visits are made by the nurse to help parents make plans for correction of defects and make use of community resources that are available.

Audiometer tests were given to two hundred sixty-four children and notices were sent to parents of any children found to have a hearing loss.

Patch tests for detection of early Tuberculosis were given to one hundred fifty-one children and fifteen were positive reactors. A positive reaction does not mean that the child has Tuberculosis but that he has been in contact with an active case and demands further investigation.

The result of the school physical examinations showed a great need for more and better dental care so a dental program was started in 1948. This program consists of examinations of the mouth of all pupils and individual instruction in dental care at that time. Sodium fluoride treatments were offered to all second grade pupils the first two years and the third year this was expanded to include the fifth and eighth grades also. This year the program was expanded to include the three year olds' group as dental authorities recommend this as the ideal age to start these treatments. Some improvement has been made in dental care through this educational experience.

Child Health Conferences for health supervision of all children from birth through school age were started. A physician is in

attendance at these Conferences and protective inoculations against Diphtheria, Whooping Cough and Tetanus and vaccination against Smallpox is offered. A total of three hundred seventy-eight infants and preschools have attended these Conferences. Physical examinations were given to eighty-six infants and one hundred thirty-seven preschools.

The immunization program has met with favorable response. During this period the following inoculations were given:

Diphtheria .....	140
Whooping Cough .....	100
Tetanus .....	75
Smallpox Vaccination .....	155

The school and preschool population are well protected against smallpox but there has been very little response from adults. Since vaccination offers one hundred per cent immunity all adults should keep up this protection.

The bedside nursing program has expanded a great deal. In comparison to thirty visits the first year, one hundred eighty-eight were made during 1951. Of these visits made, one hundred seven were to cancer patients. Since this is a chronic illness and treatment and care often present hardship, community resources are available to help in these cases. For further information about this contact the nurse at Kennebunkport 7-4401 during hours, 8:30 - 9:30 A. M.

I wish to take this opportunity to thank all who have helped make this program a success. I am especially grateful to the selectmen, health officer, superintendent of schools, the teaching staff and members of the Health Council who have furnished volunteer assistance and lent their support in so many ways. With your continued cooperation I hope to make this a healthier community in which to live.

**REPORT OF LOCAL HEALTH OFFICER, 1951**

The State Law requires the Local Health Officer to provide annually free smallpox vaccination to all citizens of the Town and inoculate against diphtheria and whooping cough to all children under 12 years of age. All charges to be paid by the Town.

In accordance with this law we vaccinated for smallpox, 5; combination diphtheria, whooping cough and tetanus, 5; and diphtheria and tetanus, 2. Total cost to the town, \$22.56.

Communicable diseases reported:

Plain Measles, 19; Chickenpox, 25; Whooping Cough, 8; Mumps, 7; Poliomyelitis, 1.

Parents should report all cases of communicable diseases to the Local Health Officer.
