## WARRANT FOR TOWN MEETING

To Ernest H. Allen, a Constable in the Town of North Yarmouth in the County of Cumberland.

### GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of North Yarmouth, qualified to vote in town affairs, to meet at the Grange Hall in said town on Monday, the thirteenth day of March, A.D. 1961 at one o'clock in the afternoon to act on the following articles, to wit:

Art. 1. To choose a Moderator to preside at said meeting.

Art. 2. To choose by secret ballot the following officers, to wit: Town Clerk; one Selectman, Assessor, Overseer of the Poor for a term of one year; one Selectman, Assessor and Overseer of the Poor for a term of two years; and one Selectman, Assessor and Overseer of the Poor for a term of three years; and in succeeding elections elect only one Selectman, Assessor and Overseer of the Poor for a term of three years. The member with one year left to serve to act as chairman; Road Commissioner, for a term of one year; Treasurer, also one member of the School Committee for a term of three years.

The Polls will be open at the Grange Hall between 1 p.m. and 7 p.m. At 7:30 p.m. the following articles will be taken up:

Art. 3. To hear and act on the report of the North Yarmouth School Fund Trustees and vote how the money shall be expended.

Art. 4. To hear and act on the report of the Cemetery Commission.

Art. 5. To hear and act on the report of the Town Treasurer, Tax Collector, Selectmen, Assessors, Overseers of the Poor, Superintendent of Schools, and Trustees of the North Yarmouth Water District.

Art. 6. To receive accounts against the town and raise money for such as may be allowed.

Art. 7. To fix compensation for town officers.

Art. 8. To choose a Cemetery Commissioner for a term of five years.

Art. 9. To elect one or more fire wards, designate one as inspector and fix compensation.

Art. 10. To elect a member of the Board of Trustees of the North Yarmouth School District to serve for five years.

Art. 11. To elect four members to serve on the budget committee for three years.

Art. 12. To see what sum, if any, the town will vote to raise and appropriate for State Subsidized school accounts to cover instruction, fuel, janitor, cleaning, conveyance, tuition, elementary, textbooks, supplies, utility service and equipment.

Art. 13. To see if the town will vote to authorize the superintending school committee to appoint a school physician.

Art. 14. To see what sum, if any, the town will vote to raise and appropriate for maintenance of town equipment.

Art. 15. To see what sum, if any, the town will vote to raise and appropriate for maintenance of town roads for the ensuing year.



Art. 15A. To see what sum, if any, the town will vote to raise and appropriate to complete the Sligo Road.

Art. 16. To see what sum, if any, the town will vote to raise and appropriate for snow removal and sanding for the ensuing year.

Art. 17. To see what sum, if any, the town will vote to raise and appropriate for repairs on the Sweetsir Bridge on the North Road.

Art. 18. To see if the inhabitants of the town will vote to authorize the Selectmen to borrow the sum of six thousand seven hundred and fifty dollars (\$6,750.00) for the purpose of paying the town's share of cost of construction of a new bridge across the Sweetsir River on the North Road in cooperation with State and Cumberland County, and to issue serial notes of the town payable as nearly as possible one-quarter of the aggregate amount, beginning with December 15, 1962, to be signed by the Selectmen and countersigned by the Treasurer, in such form and upon such interest rate and other terms and conditions as the Selectmen may negotiate on behalf of the town.

Art. 19. To see what sum, if any, the town will vote to raise and appropriate for bridges and culverts for the ensuing year.

Art. 20. To see what sum, if any, the town will vote to raise and appropriate for cutting bushes on town roads for the ensuing year.

Art. 21. To see what sum, if any, the town will vote to raise and appropriate for State Aid Construction (in addition to the amounts regularly raised for the care of ways, highways, and bridges), under the provisions of Section 25 and 29, Chapter 20, R.S. 1944 as amended.

Art. 22. To fix wages of men, teams, trucks and other equipment per day and hour.

Art. 23. To see what sum, if any, the town will vote to raise and appropriate for the support of the poor for the ensuing year.

Art. 24. To see what sum, if any, the town will vote to raise and appropriate for Aid to Dependent Children for the ensuing year.

Art. 25. To see what sum, if any, the town will vote to raise and appropriate for payment of town officers for the ensuing year.

Art. 26. To see what sum, if any, the town will vote to raise and appropriate for the care of cemeteries for the ensuing year.

Art. 27. To see what sum, if any, the town will vote to raise and appropriate for payment of interest for the ensuing year.

Art. 27A. To see what sum, if any, the town will vote to raise and appropriate to have the town gravel pit surveyed.

Art. 28. To see what sum, if any, the town will vote to raise and appropriate for contingencies for the ensuing year.

Art. 29. To see what sum, if any, the town will vote to raise and appropriate for fire protection for the ensuing year.

Art. 30. To see if the town will vote to raise and appropriate the sum of \$50.00 to be paid to the State of Maine Publicity Bureau to be expended for advertising the natural resources, advantages, and attractions of the State of Maine, in accordance with the provisions of Chapter 80, Section 95, R.S.

Art. 31. To see if the town will vote to raise and appropriate the sum of \$100.00 for Public Health Nursing in North Yarmouth, said sum to be expended by the Department of Health and Welfare for local services.

Art. 32. To choose a director of Civilian Defense, and what sum, if any, the town will raise and appropriate for the support of the program.

Art. 33. To elect a trustee of the North Yarmouth Water District to serve for three years.

Art. 34. To see what sum, if any, the town will vote to raise and appropriate for Control of Dutch Elm Disease or take any action thereon.

Art. 35. To see what sum, if any, the town will vote to take from the town surplus to apply against the ensuing year's appropriations.

Art. 36. To see if the town will vote to discount taxes or take any action thereon.

Art. 37. To see if the town will vote to charge interest on taxes or take any action thereon.

Art. 38. To see if the town will vote to set a time when taxes for 1961 shall be paid.

Art. 39. To see if the town will vote to buy a collector's and Treasurer's bond for the ensuing year.

Art. 40. To see if the town will vote to authorize the Selectmen and Treasurer on behalf of the town to sell or dispose of any real estate acquired by the town, for non-payment of taxes thereon or otherwise at such terms as they deem advisable and execute quit claim deeds for same.

Art. 41. To see if the town will authorize the Selectmen and Treasurer to procure temporary loans in anticipation of taxes, for the purpose of paying obligations of the town, such loans to be paid during the current year from money raised during said municipal year, by taxes.

Art. 42. To see if the voters of the town will vote to authorize the selectmen to select and appoint an advisory board of five town residents to assist the board of Assessors in arriving at an equitable appraisal of property values in the town. Their duties being to visit all property within the town, endeavor to arrive at a fair appraisal of each parcel and advise the assessors of their conclusions. Such board to be known as the Assessors Advisory Council and their compensation to be on the basis of \$1.00 per hour for time actually spent on such appraisal duties. Or to see if the voters will take any other action thereon.

Art. 43. To see if the voters of the town will vote to authorize the Selectmen to select, appoint and arrive at suitable compensation for a Certified Public Accountant, whose duties shall be to study the present town book-keeping system and make recommendation as to desirable changes therein, or to see if the voters will take any other action thereon.

The Selectmen hereby give notice that they will be in session for the purpose of correcting the voting list of said town, and hearing and deciding upon applications of persons wishing to have their names entered on the voting list at the Grange Hall at 11:45 o'clock in the forenoon on the day of said meeting.

Hereof fail not to make due return to one of us on or before the day of said meeting.

### COMMENTS

#### CASH

The cash balances, as noted in the balance sheet, were reconciled with the bank statements and a written confirmation of the balances was made.

#### UNCOLLECTED TAXES

A percentage of the uncollected taxes, as shown on the collector's records at December 31, 1959, and unpaid tax liens, were verified by written confirmation with the taxpayer.

#### GENERAL

The procedure for keeping the municipal records of the town officers was examined, and found to be adequate, and in compliance with the General Laws of the State of Maine, as approved by the State Department of Audit.

#### SCOPE OF AUDIT

This audit was made as required by the State Department of Audit, Chapter 405, Section 26, of the General Laws of 1957.

Records were checked to determine the accuracy of recording cash transactions. The system of internal control was reviewed as to the handling of cash and other matters of financial concern. External verifications, on a test basis, were utilized to determine the correctness of recorded assets and liabilities.



Receipts, vouchers and cancelled checks were examined, for authenticity, for a selected period. Bond and insurance coverages were examined. Excise tax collections for a selected period were verified with copies of the receipts retained by the Tax Collector.

**ANNUAL REPORT OF PUBLIC HEALTH NURSING SERVICES IN NORTH YARMOUTH**

**For the Year 1960**

Public health, in simple terms, is the sum total of the health of individuals and families living in a community. An organized program for public health is one that offers those individuals and families every possible chance of living and enjoying life, free from the handicaps of preventable disease and disability. In more formal terms, the objective of a public health program is to bring to all the people the benefits of modern medical and related sciences including the care and rehabilitation of the sick and disabled, the promotion of healthful living, and the prevention and control of disease.

A number of people are involved in the attaining of this objective. All together they make up a "health team." The public health nurse is an essential member of this team. She shares in planning and action with other workers in the fields of health, education, and welfare; with physicians, hospitals, clinics; with school personnel; with citizen

groups. One of her important functions is coordination with the others involved to provide public health services to individuals, families, and community. Citizens of the community are also essential members of the health team. Alert to the health needs of their community, taking their share of responsibility to meet these needs, their contribution as health workers is indispensable to the effectiveness of the public health program. A vital, dynamic, working "health team" in the local community strengthens the public health not only of that community, but also of the State and the Nation.

In the beginning of 1960 the health council, nurse and chairman of child health conference made plans for three child health conferences in North Yarmouth. The first one held in May had an attendance of 39 children. The chairman of the child health conference, being aware that this was too great a number of children for one doctor to examine in a two-hour period, gave 20 mothers appointments to the two child health conferences to be held in June. An extra child health conference was added to take care of the overflow of the May child health conference.

The object of the child health conference is that each child will receive a physical examination. Also, to make parents aware and recognize the needs of continuous medical supervision of their children by a physician. At the child health conference, the nurse has the opportunity to meet each mother and obtain valuable information before the child is examined. Many babies coming to child health conferences are perfectly healthy babies, but babies with crippling defects and anemia have been found and referred to family physician or the nearest facility in nearby cities.

To prevent specific diseases through immunization is not an object of child health conferences, although this service is offered to parents at child health conferences. North Yarmouth committee has been fortunate in having the very clean, roomy grange hall for child health conferences. This has proven very satisfactory to all and allows privacy for doctor and mother at the time of the examination.

Thirteen adult visits were made where the nurse was

concerned or patients referred in interest of tuberculosis, cancer and pregnancy. Your nurse visits regularly seven children who are under supervision of the State Crippled Children's Services. Other visits were made to infants and preschool children in their homes to plan medical care or correction of defects or assist with emotional problems. Two mothers wished to discuss behavior problems of their school children, and I referred these mothers to the school nurse. Home nursing is still an important part of the public health nursing program. Visits are made according to the needs to adult, infant and preschool children, and school children under the supervision of State Crippled Children's Services.

There is a need in North Yarmouth of three immunization clinics where infants, preschool and school children may be immunized against specific diseases. Also adults may receive smallpox vaccinations. This, of course, should be under the direction of the health officer who has been so cooperative and helpful in planning the health program with the health council.

I wish to take this opportunity to thank town officials, health officer, health council and individuals who have supported North Yarmouth Health Program.

### REPORT OF CIVIL DEFENSE DIRECTOR

For 1961

I accepted this appointment of C.D. Director November 23, 1960, due to the resignation of Everett H. Tinsman, to complete his term.

During this short term we have had two test alerts from County Headquarters, a test to determine: Communications, and Fanout tests. These tests were satisfactory, but there is a chance for improvement.

Efforts have been made to get instructors for advance first aid, but due to climate conditions the instructors contacted would prefer to hold these meetings in early spring.

The town appropriated \$800.00 for C.D., of this \$639.00 was spent for radio on a 46.47 MC to check in with County Headquarters; \$105.00 was spent on antenna for same. Balance of appropriation was turned back to the town.

Through your Civil Defense we are placed on the eligibility list for surplus property and equipment, and have purchased for \$409.47 surplus property at an original cost to the Government of \$5,462.10.

#### **REPORT OF THE ELEMENTARY MUSIC SUPERVISOR**

I am pleased to submit my report of weekly visits to the North Yarmouth Elementary School.

The program is being continued as was started two years ago; namely singing, theory, rhythms, listening and creating instrumental response.

A great deal of time is being devoted, especially in the lower grades to rhythmic experiences, through which the child can express and enjoy himself in singing, dancing, sharing in games, playing on rhythmic and simple melody instruments. This forms the foundation for music reading through a music reading-readiness program.

Two-part rounds are introduced in the third grade, continued in the fourth grade with simple two-part songs by rote, then followed in the fifth grade with note reading.

In the fifth grade we start three-part rounds which are followed by three-part songs in the sixth grade, continu-

ing on to the seventh grade and developing four-part songs in the eighth grade.

A xylophone has been introduced which forms accompaniment for songs and creates a strong enthusiasm to learn through experience, the beginning of piano keyboard.

A new flutephone band was organized in the fourth grade and is extremely successful. It encourages children to continue study on instruments for band or orchestra.

In February "H. M. S. Pinafore" was presented most successfully by grades fifth through eighth. This year a Minstrel Show is being prepared which will be presented in March.

The music for graduation was an enjoyable culminating program which was received with much praise.

At the present writing more time is needed in my visits to the school. The teachers and I cannot accomplish a successful program unless more time is given to the subject—"what is sown is reaped."

At this time I want to thank you, Mr. Henry G. Perkins, the Superintendent of Schools, the Superintending School Committee, and especially the teachers for their excellent work, support and cooperation, and everyone who made the year a success.

#### **SCHOOL NURSE REPORT**

The health of the school child is very important if he or she is to do the best work possible in school and become a useful citizen. All the children's eyes and ears were examined at the beginning of the year and if any defects were found the parents were notified. Patch tests were given to the subprimary and eighth grades for tuberculosis re-active. All these tests were negative, but if a re-active is found, the pupil is sent to the Maine Medical Center for a chest x-ray.

Immunization clinics for diphtheria, whooping cough, tetanus and polio were held in February, March and April. At the May clinic vaccinations for smallpox were also given. All these clinics were very well attended.

In November, physical examinations were given at the school for children in the seventh, fifth, third and first grades by the school physician, Dr. Barron McIntyre. If any physical defects were found, the parents were notified. Also in November, a clinic was held for the teachers and school personnel for flu vaccine.

Dental clinic started in September and was held for six weeks, one-half day a week. Dr. James McCullum was the dentist.

At this time I wish to thank the Health Council members and parents who have helped with the clinics.

## REPORT OF SUPERINTENDENT OF SCHOOLS

In accordance with the requirements of the laws of the State of Maine, I herewith submit the annual report and financial statement of the North Yarmouth School System for the fiscal year of 1960.

The schools opened in September 1960 with 260 pupils in the elementary grades. There were 68 students attending secondary schools. Starting in September 1961, there will be about 83 students attending high school from North Yarmouth. The average cost of tuition for the school year 1961-62 will be approximately \$450 per student. The increase in the number of students attending high school (1956—50 students) together with the rapid rise in the rate of tuition (1956—\$325/year) has resulted in a total increase for high school education of 85 per cent during the past five years. In the same period the cost of instruction in the elementary grades has risen by 50 per cent. However, during the past year three of the five teachers who left the North Yarmouth schools made the change in order to receive higher salaries. North Yarmouth has been very fortunate in obtaining the following new teachers: Mrs. Nellie Leighton, Mrs. Marjorie Dunning, Mrs. Anita Leavitt, Mrs. Bernadette Freeman, Mr. Roger Morse.

The 1960 achievement test scores for grades 2 through 8 indicated that satisfactory progress was being made in all subjects. The median score obtained by each grade at North Yarmouth exceeded the national median. The individual grade placement graph showing the accomplishment of each child in the achievement test was sent to the child's home. The parents are encouraged to discuss the general scholastic progress of the child as well as the achievement test results with the teachers.

The members of your School Committee are well aware of the inflationary spiral which is acting upon the school budget. In keeping abreast of this problem it appears that the one hope for maintaining good schools within the economic limits of the town is in joining with other towns which will give greater financial assistance from the State. The School Committee has had several meetings with School Committee members from Cumberland and Pownal and these school leaders are jointly supporting

State legislation which, if enacted, should be beneficial to towns forming School Administrative Districts.

It is a pleasure for me to thank the teachers and other school personnel for their excellent cooperation and wholehearted efforts during the past year. I wish to thank the School Committee members and parents for their sincere support during the past year.
